 - 3.1 explains difference between posted and discoverable. Discoverable means even if it doesn't fit in the portal, should be knowledge that the data exists.
 - Last bullet of this section flip/move this bullet up
- Sec. 3.2 Open Data Criteria and Assessment Requirements
 Amendment to last bullet to "The Chief Data Officer shall review the
 Open Data Assessment on a schedule to be announced
- Sec. 3.3 Additional Requirements
 Last bullet would conflict with Executive Order if wording was changed TO "shall" Bennett would like to come back and have more of a discussion on this at some point.

o Sec. 4.0 Governance and Oversight

Not significantly different from Executive Order

4.1 Agency Data Officer

First paragraph amended to "Responsible for <u>ensuring</u> the sharing of State data Second paragraph amended to add "will act as an <u>initial</u> point of contact

4.2 Agency Data Stewards (ADS) Last two sentences amended. First, to remove Each major agency business shall designate a Data Steward. Second, Each Data Steward shall be accountable to the ADO for the implementation and compliance with the ODP.

o Sec. 5.0 State Data Standards

5.2 Data Set Publishing – Tyler Kleykamp clarifies intent of paragraph, clarifies what "initial data" means
 3rd paragraph to correct and amend "aggregated"
