Pursuant to Sections 3-37(b) and 3-21(f)(2)(A) of the General Statutes, please find attached the Report for November 2022, which provides information regarding the State's cash position and bonding activity.

Cash balances for December continued to be strong, with total available cash at \$10.9 billion, including the common cash pool of \$8.4 billion as of December 31, 2022. Given current market uncertainty and the potential impact on State cash receipts and disbursements, we continue to diligently monitor, assess, and revise our Cash projections. No temporary transfers from bond proceeds investment accounts have been made since December 2017.
