Pursuant to Sections 3-37(b) and 3-21(f)(2)(A) of the General Statutes, please find attached the Report for August 2022, which provides information regarding the State's cash position and bonding activity.

Cash balances for September continued to be strong, with total available cash at \$11.9 billion, including the common cash pool of \$10.6 billion as of October 1, 2022. Given current market uncertainty and the potential impact on State cash receipts and disbursements, we continue to diligently monitor, assess, and revise our Cash projections. No temporary transfers from bond proceeds investment accounts have been made since December 2017.
