Cash balances for October continued to be strong, with total available cash at \$9.7 billion, including the common cash pool of \$8.4 billion as of October 28, 2023. Given current market uncertainty and the potential impact on State cash receipts and disbursements, we continue to diligently monitor, assess, and revise our Cash projections.
