Dear Mesdames and Messrs.:

Pursuant to Section 3-37(b) of the general statutes, please find attached the monthly report for December 2014, which provides certain information regarding the State's cash position and bonding.

The report for December 2014 shows adequate overall cash balances. However, as previously reported to you, we made temporary transfers from bond proceeds investment accounts to the common cash pool during December. These transfers were consistent with the State's long-standing and sanctioned process for managing fluctuations in the flow of cash to and from separate funds. The transferred monies were returned to their accounts on December 26th. No transfers were made in January, although more transfers may be necessary during the remainder of the fiscal year. The current projected General Fund deficit, as well as reductions and delays in federal Medicaid reimbursements in excess of \$250 million, have contributed to the low cash balances. In the meantime, our total available cash at \$1.3 billion as of January 30th remains sufficient to cover obligations.

As always, I will keep you updated on developments with our cash flow. In the meantime, should you have any questions, please feel free to call on me.
