Dear Mesdames and Messrs.:

Pursuant to Section 3-37(b) of the general statutes, please find attached the monthly report for June 2018, which provides information regarding the State's cash position and bonding activity.

Cash balances during June 2018 remained at very strong levels. Moreover, the June 30 available cash balance of \$3.4 billion represents the highest such level on record for the end of a fiscal year. No temporary transfers from bond proceeds investment accounts have been made since December 2017.

As of July 28, 2018, our total available cash equaled \$ 3.4 billion, and the common cash pool equaled \$ 2.0 billion.

As always, my office will keep you updated on developments with our cash flow. In the meantime, should you have any questions, please feel free to call.
