Pursuant to Sections 3-37(b) and 3-21(f)(2)(A) of the General Statutes, please find attached the Report for December 2021, which provides information regarding the State's cash position and bonding activity.

Cash balances for January continued to be strong, with total available cash at an all-time high of \$12.3 billion, and the common cash pool at \$9.9 billion as of January 29, 2022. Given the economic uncertainty associated with the ongoing pandemic and the potential impact on State cash receipts and disbursements, we continue to diligently monitor, assess, and revise our Cash projections. No temporary transfers from bond proceeds investment accounts have been made since December 2017.

As always, my office will keep you up to date on issues concerning cash flow and bonding programs. In the meantime, should you have any questions, please feel free to call.
