Re: Connecticut Retirement Plans and Trust Funds – 2025 Restricted Investments List

Dear CRPTF Partners:

Pursuant to the authority and duties of the Treasurer under Connecticut law, including without limitation Sections 3-13d, 3-13(g) and 3-21e of the Conn. Gen. Stat., the Investment Policy Statement and common law standards of fiduciary duty, the Treasurer may divest or decide to not further invest assets of the CRPTF. Primary among the Treasurer's considerations is the long-term economic benefit of any investments. These requirements are embedded in the investment process and incorporated in all contracts under which CRPTF assets are invested.

New Private Prisons Policy (effective July 1, 2025): Consistent with the above, the Treasurer has determined that it is in the best interest of the CRPTF to divest from and prohibit future investment in any company that is the primary operator or manager of, or that derives a significant portion of its revenues from business related to the operation of, private prison facilities in the United States ("Private Prisons Policy").

2025 Restricted Investment List (effective July 1, 2025): Attached is the 2025 Restricted Investment List, identifying the companies and securities in which CRPTF assets may <u>not</u> be invested. The restrictions described in the attached list are in addition to any restrictions or sanctions promulgated by the U.S. Office of Foreign Assets Control, other federal entity, or as may be required by contract with the Office of the Treasurer.

The 2025 Restricted Investments List includes the following categories of restrictions:

- Iran and Sudan pursuant to Sections 3-13g (Iran) and 3-21e (Sudan) of the Conn. Gen. Stat.
- **Civilian firearms**, since December 3, 2019, pursuant to the Treasurer's fiduciary responsibilities and discretionary investment authority.
- Russian-domiciled companies and Russian sovereign debt, since March 1, 2022, pursuant to the Treasurer's fiduciary responsibilities and discretionary investment authority.
- **New Private prisons**, as of July 1, 2025, pursuant to the Treasurer's fiduciary responsibilities and discretionary investment authority.

CRPTF assets are not to be invested in any of the companies or securities set forth in the attached List. Our investment officers will seek confirmation of this during quarterly and annual performance reviews. In addition, our compliance team will request certifications of compliance as part of our annual global risk assessment certification process.
