## **History and Creation of OEC**

Governor Dannel P. Malloy signed Public Act 14-39 establishing the Office of Early Childhood on May 28, 2014 to improve the delivery of early childhood services for children in Connecticut.

It's a distinct, cabinet-level agency, incorporating early childhood programs previously from:

- The Department of Education
- The Department of Social Services
- The Board of Regents
- The Department of Developmental Services
- The Department of Public Health

### **OEC's vision statement**

All young children in Connecticut are **safe**, **healthy**, **learning**, **and thriving**. Each child is surrounded by a **strong network** of nurturing adults who deeply value the importance of the first years of a child's life and have the skills, knowledge, support, and passion to meet the unique needs of every child.

## **Our Work**

OEC is a state agency that oversees a network of programs and services that help young children and families thrive. OEC is made up of various divisions and programs which include:



#### Early Care and Education (ECE)

Supports more than 400 ECE programs serving over 18,000 children in Early Start CT. This division also oversees Smart Start.



#### **Quality Improvement**

Provides early childhood professionals with supports to improve childcare practices through Elevate, OEC's quality improvement systems and training and technical assistance activities such as AQIS, SFCCNs, Registry and scholarship, ELDS and CT DOTS support



#### Child Care and Development Fund (CCDF)

Subsidizes the childcare expenses for eligible lowincome families averaging over 20,000 children per month while funding systems and policies to improve the overall quality of and increase the supply of childcare



#### **Family Support**

Home Visiting, Help Me Grow and Sparkler provide parenting and child development support to families of young children and pregnant women



#### **Parent Cabinet**

Advisory group that partners with OEC to elevate family voice and develop family-driven policies, programs, and practices



#### **Birth to Three**

Providers support families whose children have developmental delays and disabilities. Children and families are supported by licensed professionals in the child's home and community



#### Licensing

License and inspect nearly 4,000 childcare and youth camp programs to ensure health and safety



#### **Background Checks**

Oversee comprehensive background checks for childcare providers



#### **Agency Administrative Functions**

Fiscal, Legal, Communications, Grants and Contracts, Data and Research




#### **Government & Community Relations**

Legislation and policy, outreach and engagement with key stakeholders and partners



## What is Early Start CT?

Early Start CT is the new state funding stream that combines the current School Readiness grants, Child Day Care Contracts, and State Head Start supplemental grants; it went into effect July 1, 2025

\*Child Care and Development Fund (CCDF) is a federal and state partnership program authorized under the Child Care and Development Block Grant Act (CCDBG). States use CCDF funds to provide financial assistance to low-income families to access child care. In Connecticut, our child care subsidy program is Care 4 Kids.



## Families/Children Served

Early Start CT: 18,000 children

Smart Start: 916 children

Birth to 3: 7,636 Children

Head Start: 5,718 children

Care 4 Kids: approximately 23,000 children (annual average)

## **Endowment Impact to date (FY26)**

#### **Smart Start:**

- New classrooms: 15 new classrooms in 8 districts \$1,275,000
- Capital Improvement Funds requested to open additional classrooms in SFY 2027 \$1,670,000

### **Early Start CT:**

- Expansion: \$6,000,000 for approximately 1,000 spaces.
  - Request for Application, a competitive procurement process, will be posted late fall, 2025
- Per Space Rate Increases of up to 8%

## ECE Endowment Reporting Requirements

## **ECE Endowment Annual Report**

Not later than January 1, 2026, and annually thereafter, the board shall develop a report that includes, but is not limited to:

- (1) the financial health and actuarial future of the endowment based on information received from the Treasurer
- (2) the expenditures of funds from the endowment
- (3) status updates of early care and education programs, early childhood educators, families and children served, and
- (4) any recommendations for legislation.

The board shall submit such report to the joint standing committees of the General Assembly having cognizance of matters relating to education, children, appropriations and finance, in accordance with the provisions of section 11-4a of the general statutes.

## **ECE Endowment Impact Analysis Report**

Not later than January 1, 2032, and every five years thereafter, the Commissioner of Early Childhood shall prepare an impact analysis concerning the operations of the Early Childhood Education Endowment and the effect that the expenditure of funds from the endowment have had on the availability, affordability and quality of early child care in the state.

Such impact analysis shall include, but need not be limited to, (1) a report on the solvency of the endowment prepared by the Treasurer, and (2) an analysis of the effect that the expenditure of funds from the endowment has had on:

- (A) early care and education programs receiving financial assistance under Early Start CT pursuant to section 10-550b of the general statutes
- (B) early care and education programs that are not receiving state financial assistance
- (C) access of families to early care and education programs receiving state financial assistance under Early Start CT
- (D) tuition and family contribution rates
- (E) early childhood educator salaries and benefits
- (F) the state-wide demand for child care
