## Special Requirement: Incumbents in this class:

- 2. may be required to possess certification as an Insurance Rehabilitation Specialist or be eligible for certification as an Insurance Rehabilitation Specialist.
- 3. may be required to travel.

Monitors and directs medical management, peer review and rehabilitation when appropriate, monitors third party administrators and medical community to develop effective programs while managing injured workers, analyzes medical and physician charges and develops cost effective plans to return injured workers to employment when appropriate, identifies and evaluates factors within claimants home, work and medical care centers that would promote recovery, monitors medical bill costs and evaluates need for billed services and prescriptions, and monitors and coordinates lifetime care of catastrophically injured claimants.
