This report evaluates the global proxy voting activities of the following asset managers, which manage assets for the Connecticut Retirement Plans and Trust Funds (CRPTF):

The analysis examined all the votes cast by the investment managers during the fourth quarter. We compared each vote against the Connecticut policy as well as the votes of other Connecticut investment managers. We looked for cross-voting between managers and voting in conflict with the Connecticut Global Proxy Voting Policies adopted May 10, 2000.

## Summary:

State Street Global Advisors; Acadian Asset Management; Causeway Capital Management LLC; Fiera Capital Corporation; CHANNING CAPITAL MANAGEMENT, LLC; Bayard Asset Management LLC; Schroder Inv. Mgmt. Int'l Ltd. N.A., Inc. (London Branch) and Lazard Asset Management LLC are each rigorously applying the State of Connecticut global voting policies. All managers voted consistently within the policy; there were 0 instances of voting items outside the Connecticut policy during this time period.
