Arrests and The Training Required of Law Enforcement Personnel With Respect to Domestic Violence pursuant to

Public Act No. 18-5 (Effective January 1, 2019)

Your reference is directed to the **POSTC ADOPTED CURRICULUM PA 18-5** dated Nov. 8, 2018 - Sec. 2 (c). Once an Officer has completed a Dominant Aggressor analysis and arrested the Dominant Aggressor, the Officer MAY request review and advice from a State's Attorney for the Non-Dominant person. If a review and advice is sought, "THE REQUEST SHOULD BE MADE BY THE NEXT BUSINESS DAY ON A **FORM TO BE DEVELOPED"** in lieu of arresting that person or seeking a warrant.

Attached is the Form referenced above developed by the Division of Criminal Justice to be used when a request for review and advice is made to the State's Attorney in your respective jurisdictions.

The form attached to this notice is a fillable form and should be completed in its entirety for submission along with any other supporting documents that have been generated pursuant to the curriculum.
