This training is scheduled for Tuesday August 20th, 2024, from 8:30 a.m. to 12:00 p.m. at the Connecticut Police Academy, 285 Preston Avenue, Meriden, 06450. Ken Barone, Associate Director of the IMRB at UConn will be the instructor for this class.
