OLD BUSINESS

- Body Worn Camera Policy Amendment
 Chief Melanson reviewed the law changed as of October 1, 2021, Public Act 21-33.
 Policy updates were reviewed to reflect the new law. Chief Melanson made a motion to eliminate section C&D in the packet highlighted and in lieu of replace with the new statutorily language; seconded by Chief Viadero. Motion passes.
- 2. Cannabis guidance in excess of legal limit document Administrator Boisvert to send out a general notice with links that training officers can use that provide more information.
- 3. Crowd Control Policy Council Approval to move forward. Chief Mello requested a motion to accept and move the crowd control policy forward as written. Motion made by Chief Viadero; seconded Chief State's Attorney Colangelo. Motion passes.
- 4. Pursuit Policy Amendment, Chief Riddick discussed clarifying language regarding use of force stop procedures. Chief Riddick went into a detailed discussion regarding pursuit prevention. Motion made by Chief Vernon Riddick to consider new language presented to council in an email; seconded by Mr. Mike Lawlor.

 Discussion: Mike Lawlor asked about prophylactics deploying stop stick if trying to leave. Exceptions and supervisory approval were discussed. Motion passes

NEW BUSINESS

1. Discussion – feasibility of a statewide towing policy
Chief Mello spoke to an incident where a vehicle was in pursuit which was a car jacking
and because it was being towed, it was chased in one town to another and lasted 4
hours. The vehicle in custody of owner but not watched by police and some gun fire

between thieves and owner of car, no one hurt, and some vehicles hit. Chief of town and Legislator contacted on who is responsible to stay with vehicle. Continued discussion statewide and regional levels on responsibility. No motion on this incident. This body is not the one to handle this issue.

2. EMR – Basic curriculum test requirement change.
Administrator Boisvert stated OEMS changed the testing procedure for EMR. POSTC
Instructors can no longer proctor the cognitive test. Administrator Boisvert requested removing the cognitive test of EMR from the basic training requirement. Motion to

make changes by Chief Viadero seconded by Chief State's Attorney Richard Colangelo.

Discussion: How many agencies keep MRTs after, approximately 61 agencies require EMR level. A general notice will be sent out to agencies notifying agencies of the change. Motion passes.

Until such time as Probationary Officer Voeltz achieves certification, he will be restricted in his duties and assignments by the provisions of Council Regulations Section 7-294e-1(c); probationary candidates while undergoing training may not have contact with citizens unless such probationary candidate is accompanied by, and working in concert with a currently certified law enforcement officer.

Chief Joseph M. Dooley of the Southern Connecticut State University Police Department has submitted a request/waiver to reactivate the certification of Julie Mateus and waive, in full or in part the requirements for basic training. The Southern Connecticut State University Police Department has extended a conditional offer of employment to Julie Mateus to fill a vacancy in the department as an officer. Julie Mateus has completed entry level standards for appointment, as set forth in the POSTC Regulations.

Candidate Mateus began her Connecticut certification in 2010 with the New Haven Police Department. She transferred to the North Haven Police Department on 1/25/2013 where she remained until 10/2018 when she resigned as a Detective. At the time of her resignation, her certification was valid until June 30, 2020. Former Detective Mateus met all recertification requirements during her employment with New Haven and North Haven.

The certification for Julie Mateus became inactive upon leaving employment with a CT law enforcement unit. Subsequently, her certification also expired on June 30, 2020. The POSTC regulations describe a "lapsed" certificate as not employed by a law enforcement unit for more than two years. A "forfeited" certification occurs when a police officer fails to meet recertification requirements within the timeframe established by Council. The regulations provide for no procedure for forfeited certifications to be renewed. Julie Mateus has a forfeited POSTC CT Certification status.

<u>Recommendation</u> The candidate has been out of law enforcement service for three years and two months. Had Detective Mateus remained with the North Haven Police Department, her certification would have expired June 30, 2020. Pursuant POSTC requirements, all requirements for an entry level position would require a return to basic training. However, two categories weigh in favor of waiving the basic training

requirements. First, the current certification for Julie Mateus is "forfeiture." The regulations do not provide a system for reactivating a forfeited certification. The Council is thereby able to implement a review they determine to be fair. The second category weighing in favor of allowing a waiver of some or all of the basic training requirements is her previous training and certification. Although she has been removed from her law enforcement unit for this period of time, her knowledge and previous training is still relevant.

In light of the ability of Council to establish a format for a return to certification, I recommend applying the normal waiver criteria pursuant to 7-294e-2:

- 1. Previous basic training and certification: Julie Mateus was a CT certified officer for 11 years and became a Detective with the North Haven Police Department.
- 2. Formal professional and in-service training and education in law enforcement and criminal justice. During her years in police work she was compliant with in-service and certification requirements.
- 3. Length of absence from employment with a law enforcement unit. Julie Mateus has been out of law enforcement unit for three years. The one factor that favors returning to a number of courses for updates and review of pertinent topics.

Applying these standards and the comparing courses that have changed significantly within the past four years, and the position that Officer Mateus would be performing with the Southern Connecticut State University Police Department as a Patrol Officer, my comparison would support the following recommendation:

The request is made due to an extension of Probationary Officer Lendof's Field Training hours. The Connecticut State Police request a 3-month extension of the officers one-year probationary period to April 14, 2022.

Section 7-294d(5), CSG requires that "all probationary candidate receive the hours of basic training deemed necessary before being eligible for certification, such basic training to be completed within one year following the appointment as a probationary candidate, unless the candidate is granted additional time to complete such basic training by Council."

The Policy of the Council, as delineated in General Notice 92-01 provides the possibility of approval of the request as follows..." The Council may grant an extension of time to any probationary candidate who applies for same in a timely manner, with the endorsement and concurrence of the candidate's law enforcement unit, and who by virtue of being injured or taken ill, or because of circumstances beyond the control of the candidate was rendered incapable of performing police duties and the training requirement during the time period required by Council."

RECOMMENDATION

The Certification Sub-Committee Unit recommends the Council approve an extension of the one-year probationary candidate status for Trooper Trainee Lendof for a period not to exceed Midnight, April 14, 2022.
