- 1) Academy Administrator's Report
 - a) In Service Mandatory Hour Change:

Academy Administrator Boisvert requested the removal of the one hour of gangs from in-service and to add the following courses: 410 – Citizens with Special Needs; 412 – Cultural Awareness; 413 – Fair and Impartial Policing; 416 – Procedural Justice; 419 – Implicit Bias and highlighted Use of Force to show that POST is already doing this training in Firearms which has a 2 hr. annual practical requirement and 1 hr. annual of use of force classroom.

The three year review training period will remain at 60 hours - 31 hours of mandatory topics and 29 hours of electives which will allow the agencies to choose based on training needs. The effective date will be July 1, 2021 to June 30, 2024.
