Chief Keith Mello, POST Council Chairman, called the meeting to order at 9:01 a.m.

# 2. Chiefs/Public Comment

King addressed the Council to voice his concerns of the Policy known as Section 14 of HB 6004 State of CT Modern Policy Section B: "Any plain clothes officer working an assignment which he or she is working with public shall adorn an official badge of agency and displayed on the

outermost uniform, with name plate and name tag if applicable." Mr. King expressed the concern of citizens in our State when it comes to identifying themselves as an officer as a whole. Stating that an officer doesn't always tell their name or badge numbers to individuals who may or may not be able to read. Mr. King also stated that officers should verbally have to state their names and badge numbers.

The last session 223 commenced September 14, 2020 with 17 recruits graduated in May; basic training director has met with them and will conduct an inspection prior to commencement and must pass this inspection no more than 90 days from approval. 1. Bridgeport Police Department – Tier 1 Accreditation

# **INFORMATION ITEMS**

1. Academy Administrator's Report – Written Report Submitted

Administrator Boisvert provided a written report and highlighted the filling of positions, conducted interviews for the part time per diem law enforcement officer position, and was granted a field program consultant position which closed and hope to have on board sometime in November. Due to COVID, it is required that any recruit that comes to POST must be vaccinated.

Administrator Boisvert discussed two Academies that started at POST session 373 and CSP. Due to COVID, CSP is going remote for 10 weeks and then residential. POST is a commuter session and session 373 will remain a commuter this is due to limited staffing; difficult to sanitize daily. Satellites are working collectively and getting classes filled.

2. Subcommittee Reports

Accreditation

a. CLESP updates

Administrator Boisvert gave highlights of the CLESP updates/changes that were included in the packet.

DISCUSSION: Captain Mark Davison requested clarification on whether ARIDE certification are going back to a certain date of the recruit class that just graduated? Discussion offline for next meeting.

## Curriculum

- a. 104 History of Policing and Civil Rights Movement goals and objectives (4hrs)
- b. 104 History of Policing and Civil Rights Movement Instructor criteria
- c. 209 Use of Force Instructor criteria update

Chief Mello entertained a motion to move items a, b & c forward.

Administrator Boisvert discussed the 209 instructor criteria updates to include Use of Force Train the Trainer, presented goals and objectives for 104 curriculum and instructor criteria. Information was provided in packet.

Motion made by Chief Fernando Spagnolo; seconded by Michael Freda. Motion passes.

# Social Justice Advisory Committee

a. Committee members

Voted in May for this committee was to represent the interest of all disadvantage minority groups, disabled, communities, racial groups, poor, homeless, and marginalized groups. The goal is to meet 4 times a year, advise and recommend Posting councils on areas of standards and regulations to social justice issues. Mission of committee was read as copy in packet. This committee can do research and gather data to support information. Twenty-one invitations were sent out, currently 15 are on committee and looking to continue to hear from others to join. Chaired by Chief Vernon Riddick.

#### 3. Correspondence

- a. King (My State Transparency) Email name badges (August 18, 2021) Chief Mello discussed providing your name as an officer to an individual when asked should be encouraged. Policy Section 14 that Mr. King is referring comes from the State Law PA 20-1 we must follow the law. Expectation of law each chief will follow it. Chief Mello stated to Chiefs to instruct their officers to provide their names and badge numbers clearly defined. Policy is relative to the state law statue.
- b. Dr. James Nardozzi letter to Council (June 11, 2021) No discussion.

# **OLD BUSINESS**

1. Crowd Control Policy update

Attorney Colin Milne updated on Crowd Control Policy to Post Council for review which was presented back in March 2020. Attorney Milne reported still have not received any comments on regulations progress and has extended since then. Ready to submit to Attorney General and then to Legislation.

## **NEW BUSINESS**

- 1. Bill No. 1201 An Act Concerning Responsible and Equitable Regulation of Adult Use Cannabis DRE's
  - a. January 1, 2022, POSTC shall issue guidance concerning how police shall determine whether the cannabis possessed by a person is in excess of such person's possession limit (page 241 of Bill)
  - b. January 1, 2022 each law enforcement unit shall report to POSTC in the manner specified by the council, a minimum number of DRE's (page 158 of Bill)
  - c. January 1, 2022 POSTC ARIDE Training for each PPO following completion of Basic Training (original certification) shall complete ARIDE prior to being recertified pursuant to section 7-294e of CGS (page 159 160 of Bill)
  - d. January 1, 2022 POSTC & DOT jointly issue a plan to increase access to ARIDE and DRE training (page 159 of Bill)
  - e. April 1, 2022 POSTC shall develop and promulgate a model policy to ensure enough police officer become trained drug recognition experts in each law enforcement unit (page 159 of Bill)
  - f. July 1, 2022 POSTC and DOT issue a report to the Governor and OPM on minimum number of police officers to be accredited as drug recognition experts for each law enforcement unit (page 159 of Bill)
  - g. October 1, 2022 each LEU shall adopt and maintain a written policy that meets or exceeds POSTC policy (page 159 of Bill)

Administrator Boisvert gave update issuing guidance. Working with the group and hoping to have something by November 2021. Received agency reporting form to calculate minimum number of DRE's they need by January 2022 to Post Council.

Chief Vernon Riddick discussion on vehicles taking off and stolen cars on the policies and clarifications on pursuits and the languages. The Force Stop and State Pursuit policies and measures are only applicable if you have a pursuit. Discussion on tire deflation devices language.
