1. Academy Administrator's Report

Academy Administrator Boisvert announces that we have hired three new people since our last meeting, Gary Nevola, Training Officer; Jessica Blank, Field Program Consultant; Michael Francis, Field Program Consultant Academy Administrator Boisvert congratulates Lieutenant Ryan Maynard on his promotion and announces he is now the commander at the State Police Training Academy.

Academy Administrator Boisvert also explains that we have lost our location for EVOC training and all efforts are being made to find a new site. Starting in January, we will have four training academies per year. Academy Administrator Boisvert states they have also added seats to each class.
