2. Subcommittee Reports

Chief Vernon Riddick updates on the Social Justice Advisory Committee and the tasks they are currently working on. One, developing public trust. Two, Background checks in departments when hiring. Three, minimalizing fiscal impacts on new regulations.

Chief Keith Mello updates on the Action Committee and the February 2023 meeting.

- 3. Chief Mello updates on the report from an in-custody death in Norwich investigated by the Inspector General's office. It is believed that a fentanyl pill was located on the suspect in their hoodie and taken shortly before arrest. The Inspector General recommends suspects have clothing removed and returned after the arrest process.
- 4. A new level of appeal is being proposed in the decertification process. Chief Mello explains the decertification process for the Council. This proposal would add a third level after the Council's decision to allow an additional process for the potentially decertified officer prior to going to court.
- 5. Loan Forgiveness Program

Division Director McGuffey discusses the proposed process for the student loan forgiveness for certified police officers. Chief Paul Melanson creates a motion to create a subcommittee to discuss this item and Chief Rosado seconds this motion. The motion passes.
