CALL TO ORDER

Meeting was called to order at 9:02 AM.

ACTION ITEMS

 Attorney Jeff Ment addresses the Council regarding Amanda Wauffle, who has a request to waive the requirements for basic training. The Mashantucket Police Department seeks to hire her and complete her FTO portion of training.

 Chief Duane Lovello, Professor Wilson and Ken Barone present the Hate Crime Policy to the
 Council. Chief Lovello presents the history and the members of the committee who worked on the
 policy until its completion.
 - Chief Melanson motions to approve the policy. Lieutenant Maynard seconds. The motion is discussed. Chief Mello thanks the Hate Crimes committee for their work on the policy and their presentation to the Council. The motion passes.

Administrator Boisvert presented the Seat Belt Policy to the Council. A motion to accept the policy is made by Chief Melanson. Chief Higgins seconds. The motion is discussed. Administrator Boisvert states the subcommittee that created this policy reached out to several stake holders including DCF and DOT. Chief Melanson comments regarding the importance of documenting why an officer may not seatbelt an offender due to safety concerns for the officer and that they should not be punished by decertification if they are not seat-belting due to safety concern. Professor Lawlor notes that the policy only applies to people in custody. He questions whether a policy will be created for officers on when they have to seatbelt themselves when in a police vehicle. Chief Mello comments that most departments internally have their own policies. However, some departments may not and Chief Mello notes this may be a good item to add to accreditation standards. The motion passes.
