### **OLD BUSINESS**

#### 1. EMR In Service Update

Administrator Boisvert requested EMR be removed from the basic training curriculum and requested it to be replaced with a robust emergency medical training. Agencies needing the EMR certification will be provided two classes per year – POST field services. The cost of the program is approximately \$900 per student. Agencies enrolling officers in this program will pay a \$300 fee and DESPP will absorb the remaining amount for each student. This is still being finalized with fiscal and should not be treated as the final word regarding cost. Pricing will need further discussion. Chief Riddick asked if there will be a reduction in the basic training cost and length of basic training. Administrator Boisvert explained class reduction time is not likely due to additional items placed in the curriculum – such as TIMS.

EMR will remain in the basic training curriculum and recruit programs until details are worked out with pricing and length of time for classes. Lieutenant Maynard also asked to evaluate the cost of EVOC because CSP does cover a lot of the expenses.
