Chief Mello addresses items 1-2. Both agencies have been in contact with POST staff and cite difficulties in staffing at their agencies as the reason that they are not in compliance. POST staff is in contact with the agencies regularly and will assist the agencies as necessary. Letters to both agencies will be sent stating they are not in compliance with regulation.

NEW BUSINESS

Discussion regarding the review of the POSTC Pursuit Policy in accordance with CT P.A.
 19-90 – Chief Mello

Chief Mello gives a brief history of legislation related to the model pursuit policy. The policy has to be reviewed every five years per legislation. There have been a number of updates to new technology since the release of the last policy and Chief Mello has decided to establish a working group to review possible changes to the policy. Staff from the Commissioner's office, members of the CPCA, staff from the Chief's States Attorney's office and Jessica Gouveia will all be invited to participate. Chief Mello will report the members of the committee at the January meeting.

2. Open Cary Reporting Public Act 23 – 53 – Ken Barone

A motion to adopt the form as written is made. Ken Barone introduces the form for reporting stops related to open carrying per PA 23-53. Ken states the form is straightforward and simple to fill out. There will be an instruction manual and policy released when the form is rolled out. Ken states that he does not anticipate many submissions. Chief Melanson questions whether the form is requesting too much data that isn't required that could possibly be misconstrued. Discussion involving when the form should be submitted ensues, including debate over whether to submit every time there is an occurrence or on a yearly basis.

The motion is amended to postpone the vote until further review can be performed. The motion is voted on and approved unanimously.

3. Social Workers Guidance document to Law Enforcement Public Act 23-104 – Attorney Gouveia

Chief Mello discusses the theory of social worker collaboration with law enforcement. Chief Mello thanks Attorney Gouveia and Attorney Strom on their work. A motion is made to approve the document as written. The motion is voted on and approved unanimously.

4. POSTC BWC Policy Revisions – Attorney Strom

A motion is made to accept the policy as written. Chief Mello explains revisions that were made to the BWC policy to include addition of definitions, clarity around when an officer shall not deactivate BWC but may mute the BWC during an interaction with the public, language that had been inadvertently omitted from the policy during its last revision, and citations and legal support. Chief Dryfe questions the disclosure section of the policy and is concerned that the policy is not clear enough. The motion is withdrawn to allow further review and to discuss again at the January meeting.

5. Death Notification Policy – Attorney Strom

A motion is made to accept the policy as written. The motion is voted on and is approved unanimously.

6. Working Group Malfeasance Definition Update CT G.S. 7-291(c) – Attorney Strom

A motion is made to accept the memo as written. Attorney Strom thanks the committee members who worked to create a better definition of malfeasance. In the memo dated 09/24/24, several definitions were included to better clarify for agencies. The motion is voted on and passed unanimously.

REPORT ON MATTERS OF ADMINISTRATION

Hearing Officer for Contested Hearings in Revocation Proceedings – Chief Mello

Chief Mello discusses revocation hearings and how POST has seen a big increase in cases. Chief Mello is in discussions with the Commissioners officer and is working to streamline the process.

2. DESPP – Commissioner Higgins

Commissioner Higgins briefs the Council regarding changes at POST. He introduces Chief Thomas Wydra, formerly of the Hamden Police Department who has been appointed the

Executive Director of POST. Chief Wydra's mission is to (1) review all policies and procedures at POST, (2) review technology and possible advances needed to train recruits and staff, (3) provide support to Post Council, (4) assess the POST academy in comparison to regional and satellite academies, (5) review in service training options, and (6) review training opportunities for POST staff including professional development. The Commissioner held a meeting with POST staff in November and will hold another meeting in late February or March. Commissioner Higgins highlights that POST will continue to work with the Chief States Attorney's office to continue to bring in staff to teach at POST. Chief Freda highlights Chief Wydra's commitment to law enforcement. Chief Mello states that he has continued to advocate for more resources for POST with the Commissioner.
