REPORT ON MATTERS OF ADMINISTRATION¹

1. DESPP – Commissioner Higgins

Commissioner Higgins opens floor for Attorney Sarah Karwan regarding classification of Taser 10 as a firearm by ATF due to its platform which uses an explosion of gun powder to expel the projectiles. There is discussion of the need for POSTC Use of Force Model Policy to be updated. Specifically, language on page 8 of the policy will need to be modified to reflect that despite ATF's classification of the Taser 10 as a firearm, POSTC does not consider electronic defense weapons to be deadly force. There will also need to be an accompanying change to the General Statutes. Theoretically, if the policy and statutes are not changed, use of the taser 10 could trigger an investigation by the Office of the Inspector General for even routine taser uses.
