**COURSE ANNOUNCEMENT**

The Department of Emergency Services and Public Protection, Police Officer Standards and Training Council's Field Services Training Division is offering a three-day training program to train officers to be Field Training Officers (FTO).

**Monday March 13, 2023 - Wednesday March 15 2023** from 8:00 a.m. to 4:00 p.m.

Lt. Masi (West Haven), Sgt Morgan (Rocky Hill), Sgt Martin (Berlin) and Training Officer Brian Reilly of the Connecticut Police Academy (POSTC) will be the instructors for this class.

This course is specifically designed for experienced uniformed patrol personnel selected to serve as Field Training Officers with probationary employees. The course emphasizes the FTO's role in assisting probationers in certifying for solo patrol operations by applying the knowledge and skills acquired during Basic Police Training and using them according to agency policy, procedures and community service delivery standards and the POSTC Field Training and Evaluation Program.

Topics that will be covered include:

- Liability
- Operational Authority Key Elements
- Phase Training Evaluation Process
- Standard Evaluation Guidelines
- Recruit Proficiency Check-off List
- Development of Effective Teaching Skills
- Beginning the Field Training Experience
- Remediation
- Termination

**Please note: POST regulations require that any officer being considered for an FTO assignment must have at least three years as a certified officer or a signed waiver (attached to this posting).**

This course will be offered concurrently with each new recruit class and departments with recruits seated in each class will receive preference in attending the training.

The class is limited to 35 attendees.
