COURSE ANNOUNCEMENT

The Department of Emergency Services and Public Protection, Police Officer Standards and Training Council's Field Services Training Division is offering a five (5) day **Basic Interview & Interrogation Techniques** course from Monday, **February 27, 2023, to Friday, March 3, 2023.** The training will take place at the Connecticut Police Academy, 285 Preston Avenue, Meriden, CT from 0830 to 1630 hours daily. The course will be presented by BOWMAC Educational Services/RSI, Inc.

The program is designed to provide investigators with proven techniques that can be applied in various accusatory and non-accusatory interview situations. Participants will develop skills in preparing for the interrogation with a "game plan" which will emphasize a proactive, rather than a reactive role. The program includes up-to-date information on the legal aspects of interrogation and admissibility of the confession into court. Students are constantly challenged to perform and respond in both formal and informal role play situations to demonstrate mastery of the techniques.
