COURSE ANNOUNCEMENT

The Department of Emergency Services and Public Protection, Police Officer Standards and Training Council's Field Services Training Division, is offering two, 2-hour training seminars titled "**Risk Protection Order Investigations – Train-the-Trainer.**" This course will be presented by members of the Connecticut Coalition Against Domestic Violence (CCADV). **This training is mandatory for all POST Certified instructors endorsed to teach Domestic Violence (607).**

This Train-the-Trainer program will provide all attendees with materials and information regarding the new Risk Protection Orders Investigation, notification requirements, and the NEW Family Violence Model Policy pursuant to Public Acts 21-78 and 22-47.

Following completion in this Train-the-Trainer program, attendees will be able to train new Domestic Violence Instructors to be eligible for the area 607 (Domestic Violence) endorsement.
