## COURSE ANNOUNCEMENT

The Department of Emergency Services and Public Protection, Police Officer Standards and Training Council's Field Services Training Division is offering a two (2) day, training seminar on "Use of Force Investigations - Ensuring Effective and Constitutional Policing." This training session is scheduled for Thursday, July 14, 2022 to Friday, July 15, 2022, from 8:30 a.m. to 4:30 p.m. at the Connecticut Police Academy, 285 Preston Avenue, Meriden, CT. The seminar will be presented by Eric Daigle of the Daigle Law Group.

This two-day seminar is designed for all levels of law enforcement supervisors and investigators from sergeant to chief. The seminar will focus on investigating use of force standards under proper use of force policy, federal Constitutional law, and common police practices.

The use of force civil liability portion of the seminar reviews the federal standards of 42 USC Section 1983 litigation against law enforcement officers, command staff, and municipalities. The training also focuses on the analysis of standards applicable to supervising and conducting use of force investigations. This training reviews and discusses the legal standards applicable to Section 1983 actions to include Fourth Amendment violations and the practices under 42 USC § 14141

The training will include a review of investigating force operations and policy standards to include:

- Responsibility for investigating use of force incidents.
- Detailed review of force levels.
- Instruction and response to each applicable level of force.
- Supervisory responsibilities including required response.

Also covered is how to develop a reportable use of force form, how officers should complete the form and what supervisors should be looking for on review. Through lecture, video instruction and table-top exercises, attendees will learn the importance of drafting use of force reports under the proper constitutional and case law standards. Each element of proper force investigation will be analyzed.
