## **COURSE ANNOUNCEMENT**

The Department of Emergency Services and Public Protection, Police Officer Standards and Training Field Services Training Division in conjunction with the Office of the Chief State's Attorney (OCSA) has scheduled <u>ONE</u> mandatory training session on September 15, 2023, from 9:00 AM to 1:00 PM. Registration will begin at 8:00 AM. This training will be held at Choate School's Colony Hall. The address for directions (Primary parking lot) is, 333 Christian Street, Wallingford, CT 06492.

## **Special Instructions:**

- Parking immediately adjacent to the venue is limited to 120 vehicles. It is requested
  that individuals from the same agency carpool as much as possible. Personnel will be
  on hand to direct you to alternate parking.
- If you are NOT in uniform, weapons MUST be covered/out of sight when not in the training room, at the request of the school.

Those **REQUIRED** to attend this training are **LIMITED** to very few identifiable people. In most cases it is the Chief of Police **and** the second-in-command. Any law enforcement unit, which has more than one second-in-command (e.g., two deputy chiefs or a unit in which the Chief of Police and his second-in-command go on vacation simultaneously) should send the individual who would most likely be designated to serve in the absence of the Chief. Any questions on who **must** attend can be directed to the Director of Field Services Training Division.

The session will focus on new Public Acts and any recent decisions of the U.S. Supreme Court, Second Circuit Court of Appeals, and the Connecticut Appellate Courts which have direct impact on police work in Connecticut. The training will be instructed by the Office of the Chief State's Attorney and others.

Attendance in this class is unlimited and **NO CONFIRMATION WILL BE SENT.** Please complete a registration form for each attendee from the web and email it to William Tanner at <a href="william.tanner@ct.gov">william.tanner@ct.gov</a> no later than close of business, Thursday, August 10, 2023, so that course material can be printed.
