COURSE ANNOUNCEMENT

The Department of Emergency Services and Public Protection, Police Officer Standards and Training Council's Field Services Training Division is providing a series of 2-hour **Use-of-Force** "Train the Trainer" (T-t-T) Refresher sessions on the POSTC Use-of-Force Training Program. This training is meant for instructors who previously attended the full 4-hour training class and need the mandatory annual refresher. The training will take place at the Connecticut Police Academy, 285 Preston Avenue, Meriden, CT 06450.

This course is required for instructors who already have the 4-hour initial training and are teaching all subcategories within the following subject areas; 301, 302, and 306, as well as endorsement areas 203, 309, and 312.

Training will be on Wednesday, January 17, 2024, with two different sessions offered,

Morning session 0900 to 1100
OR
Afternoon session 1300 to 1500

The course revisits the <u>Model Policy</u> covering all components of the Policy and related legal, moral, and ethical requirements and expectations.
