COURSE ANNOUNCEMENT

The Department of Emergency Services and Public Protection, Police Officer Standards and Training Council's Field Services Training Division, is offering a five-day training seminar titled ***"Basic Survival Spanish for Law Enforcement: Spanish Language and Culture Training."*** This course is scheduled for **Monday, February 26, 2024**, through **Friday, March 1, 2024**, from 8:30 A.M. to 4:00 P.M. at the Connecticut Police Academy, 285 Preston Avenue, Meriden, CT.

This course is intense language and cultural training for police. The instruction is entirely job specific and assume NO previous knowledge of Spanish. The class requires the full participation of every student. The course concentrates on spoken Spanish with continuous drilling and repetition.

The goal of this course is to enable students to gather information, ask informal and formal questions to a Spanish speaker, arrest and control a dangerous contact, be aware when a risk arises to the officer's safety, and to be culturally aware of the intrinsic behavior characteristics of a Latino.

The instructional objectives are:

- Understand the basics of Hispanic culture & ethnicities
- Understand some slang and "Spanglish"
- Basic sounds of the alphabet

- Phrases for gathering information
- Verbal commands and simple interviewing
- Key phrases for officer safety
- Asking short questions
