In addition to his various roles within the Manchester Police Department, in 2001 he founded the Blue Angels Foundation, a non-profit 501(c)3 organization that provides an annual holiday party and gifts for 300 low-income Manchester children and Christmas Day gift delivery to an additional 100 children with assistance from the Manchester Police Department. Bernie continues to act as its Chief Executive Officer and chairs the organization's Board of Directors.
