### **REQUEST FOR INTERVENOR OR PARTICIPANT STATUS**

#### ***Instructions:***

This request must be filed as a motion in the docket in which you seek intervenor or participant status. If you seek intervenor status, you must complete sections I, II, and IV. If you seek participant status, you must complete sections I, III, and IV.

#### **Intervenor Status**

To be designated as an intervenor in a contested case, a person must submit “a written petition to the agency . . . at least five days before the date of hearing; . . . that demonstrate[s] that the petitioner's participation is in the interests of justice and will not impair the orderly conduct of the proceedings.” General Statutes § 4-177a(b).

If a person is permitted to intervene, the Authority “will determine the proposed intervenor's participation in the hearing, taking into account whether or not such participation will furnish assistance to the commissioners in resolving the issues of the contested case.” Conn. Agencies Regs. § 16-1-18(c).

Specifically, the Authority “may limit the intervenor's participation to designated issues in which the intervenor has a particular interest as demonstrated by the petition . . . [and] may further restrict the participation of an intervenor in the proceedings, including the rights to inspect and copy records, to introduce evidence and to cross-examine, so as to promote the orderly conduct of the proceedings.” General Statutes § 4-177a(d).

#### **Participant Status**

Any person granted permission by the Authority to take part in an uncontested proceeding shall be designated a participant. Conn. Agencies Regs. § 16-1-135(a). Except as provided under General Statutes § 16-19pp, the Authority determines “the nature and extent of a participant's participation in the uncontested proceeding, taking into account whether such participation will furnish assistance to the Authority in resolving the issues of the uncontested proceeding.” Conn. Agencies Regs. § 16-1-135.

In an uncontested proceeding on issues affecting ratepayers, ratepayers are provided with equal status and the same rights of participation as that of a public service company. General Statutes § 16-19pp. Such ratepayers may file with the Authority a notice of intent to be a participant. Id.
