- 1. Review of OPM Contracting Reports for Fiscal 2016
 - a. POS Purchase of Service Contracts
 - Run reports to fulfill requirements of 4-70b Report on contracting activity and determine financial condition of non-profits and community based health and human services agencies
 - ii. Cannot be used to purchase from individuals, administrative services, material goods, training or consulting
 - iii. Agencies with over \$300k must have uniform audit each year
 - iv. Data compiled from Core-CT agencies required to post data to system
 - v. Report calculates various financial ratios no interpretation or judgment given
 - vi. Listing is by agency/contractor by alpha/contract by year originated
 - vii. Bid/no bid identified data but not summarized
 - b. PSA Personal Service Agreements
 - i. Run report to fulfill requirements of 4-212 used to purchase in-frequent and non-routine services and end products i.e. consulting, technical assistance and training
 - ii. Not included in PSA contracts:
 - 1. Those under 4a-50
 - 2. Those hired by DAS, Div. of Construction (4b-55)
 - 3. Certain consultants hired by DOT (13b-20b)
 - 4. Agencies of the Federal and State governments
 - 5. Certain consultants hired by DAS, bureau of Enterprise Systems and Technology (4d-2© (5)
 - iii. Using a PSA must follow standards determined by OPM
 - 1. Each agency must establish procedures for compliance with above
 - iv. Agencies entering privatization contracts must determine if such contract is more cost effective method for delivering services (4e-16)
 - 1. Does not apply to new contacts for services already privatized
 - v. Contracting for legislative and judicial branches are excluded
 - vi. Competitive bid contracts
 - 1. Payments

- vii. Contracts are listed by agency, by contractor, by contract, by date originated
- c. PSA Listing of contracts by contractor in descending order
 - i. Does not tie to OPM report above off by about 1%
- 2. Observations
 - a. POS contracts 69% of total health and human services agencies
 - i. No privatization concerns here
 - ii. Contract agencies over \$300k have a single audit done annually
 - iii. Financial ratios are computed by year and by historical trends
 - 1. No interpretation of results given
 - iv. No determination of bid versus no-bid contracts noted
 - 1. Presented by contract but not summarized
 - b. PSA contracts 31% of total in-frequent and non-routine consulting, technical assistance and training
 - i. Excluded
 - 1. DAS Division of Construction, Enterprise Systems and technology
 - 2. DOT Certain consultants
 - 3. Agencies of State and Federal government
 - 4. Legislative and judicial branches
 - 5. Ongoing and frequent purchases of materials, supplies and services
 - 6. Other?
 - ii. Privatization requirement of most cost effective approach only performed on initial privatization not continuing
 - iii. Non-competitive contracts total 74% of total contracts

 - 1. Huge amounts being paid to "in-frequent and non-routine" contractors over several years
 - a. Perhaps these contracts should be segregated into non-routine versus routine services and contracted as such
