## Director's Updates: The K-3 Literacy Plan for the Center for Literacy Research and Reading Success CONNECTICUT Education

#### **Update on Connecticut's K-3 Literacy Strategy:**

- Per Connecticut General Statutes (C.G.S.) Section (Sec.) 10-14gg, the Center for Literacy Research and Reading Success (Center) shall be responsible for researching and developing, in collaboration with the Office of Early Childhood, a birth to grade twelve reading success strategy to be included in the alignment of reading instruction with the two-generational initiative, established pursuant to C.G.S. Sec. 17b-112l.
- The K-3 Literacy Plan for the Center for Literacy Research and Reading Success (p. 7), created with the Council, includes the creation and posting of Connecticut's K-3 Literacy Strategy under Center Strategic Goal 2: Serve as a collaborative research center to strengthen educator preparation program (EPP) staff knowledge and understanding of culturally responsive, specifically based, evidence-based literacy instruction implemented within a MTSS framework.
- **September 2022 December 2022:** The director of the Center worked with the Council to complete <a href="Connecticut's K-3 Literacy Strategy">Connecticut's K-3 Literacy Strategy</a>. It was posted February 2023.



# Draft 2024-26 Reading Leadership Implementation Council Goals



The overarching goal of the Reading Leadership Implementation Council is to support and inform the Center for Literacy Research and Reading Success (Center) regarding the implementation of all elements of the Right to Read Legislation. This includes:

- 1. Communicating to the Council and Center feedback regarding successes and challenges related to the implementation of the Right to Read Legislation and the provision of technical assistance to those districts whose Waiver of Connecticut Approved K-3 Reading Curriculum Models or Programs was not approved.
- 2. Identifying ways to expand Connecticut's K-3 Literacy Strategy to include Birth-3 and grades 4-12.
- **3. Ensuring** decisions regarding Connecticut's Approved K-3 Reading Curriculum Models and Programs are grounded in evidence-based literacy strategies and effective reading instructional practices.

As a result, 100% of Connecticut districts and Charter Schools will deliver evidence-based, comprehensive, core literacy instruction to promote success for all students.
