Executive Summary

Introduction

Odyssey Community School (Odyssey) opened in the fall of 1997. Odyssey is a state charter school serving a maximum enrollment of 328 students with an approved charter to serve Grades K-8. The school was granted a five-year renewal by the State Board of Education (SBE) on March 4, 2020. Five years is the maximum number allowed by state law, and is reserved for schools found to have a successful model resulting in strong student outcomes, a positive school climate, financial and organizational health, promotion of equity by effectively attracting, enrolling, and retaining students and is in compliance with applicable laws and regulations.

Odyssey's charter amendment proposal (Attachment A), asks the SBE to consider amending its charter to:

- expand grade configuration to add PK (36 seats), in 2022-2023; and
- increase current enrollment by 45 seats to 373 (9 of which will be distributed across Grades K-8).

The Connecticut General Assembly passed a 2022-23 state budget that financially supports a seat increase for Odyssey Community School.

As Odyssey is in Manchester and within the Sheff Region, Manchester resident-students may apply and attend any of the Sheff region magnet schools. However, there is a shortage of PK seats. For the 2020-21 school year, the Sheff Office received 1,271 applications from Manchester families seeking PK seats. Of those, 799 did not get offers.

Background/Process

Connecticut law requires that a charter school governing council that "plans to make a material change in the school's operations" submit such request to amend its charter to the SBE. The law defines "material change" to be "a change that fundamentally alters a charter school's mission, organizational structure or educational program," including, among other things, changing a school's grade configuration; opening an additional school building; or increasing or decreasing the total student enrollment capacity by 20 percent or more (Connecticut General Statutes (C.G.S.) Section 10-66ss(a)).

In accordance with C.G.S. Section 10-66ss, the SBE must review the charter school's amendment proposal, solicit comments from the board of education in which the charter school is located, and vote on the proposal. On May 19, 2022, the Connecticut State Department of Education (CSDE) solicited written comments from the board of education in which the charter school is located.

Recommendation with Conditions

Based on Odyssey Community School's demonstrated record of success, the financial support afforded in the 2022-23 state budget and the shortage of PK seats in Manchester, the CSDE recommends approving Odyssey's charter amendment request to add Grade PK, in 2022-2023, and increase maximum approved enrollment capacity to 373.

Odyssey Space Requirements

Odyssey School has recently re-negotiated a long-term extension to our current lease. This lease will carry us through at least the next decade with a marginal increase at 5 years out and another small increase again at 10 years out. This has provided us with the opportunity to consider adding additional space (19000 square feet) in our building at a further reduced rate (cost per square foot) that would allow us the following:

- · Additional middle school space for world language programming,
- Additional elementary space for reconfiguring existing space to address our current need for additional office space and small group instructional space,
- Two preschool classrooms for 36 additional students.
