SUBJECT: Approval of Charter School Enrollments

Introduction

There are currently 21 state charter schools in Connecticut serving 7,966 students and one local charter school serving 70 students. Additionally, two new state charter schools will open for the 2015-16 school year. In accordance with Section 10-66bb(c) of the Connecticut General Statutes (C.G.S.), the Connecticut State Department of Education (CSDE) seeks the State Board of Education's (SBE) approval of charter school enrollments for the 2015-16 school year. Consistent with C.G.S. § 10-66bb(c), the CSDE requests, within the confines of the state budget enacted by the Connecticut General Assembly, to apportion available seats based on each school's capacity and demonstrated record of achievement.

Background

The CSDE seeks the SBE's approval of charter school enrollments on an annual basis. In August 2014, existing state charter schools submitted projected enrollment requests for 2015-16 to the CSDE, which the Department analyzed and used to inform its state budget request. In April 2015, the CSDE asked each school to confirm its initial projections by submitting an updated request for seats based on projected student enrollment for the 2015-16 school year. Existing charter schools were afforded a final opportunity to amend the April 2015 request, after passage of the state budget.

This proposal reflects a total of 9,201 seats in state charter schools and 102 seats in a local charter school during the 2015-16 school year. The 9,201 state charter seats represent an increase of 1,024 seats compared to the 2014-15 SBE-approved enrollment levels. Six hundred and six of the 1,024 new seats are for existing state charter schools and 418 are for new state charter schools opening in 2015-16. Applying the statutory per-pupil rate for state charter schools of \$11,000 for 2015-16, these totals are within the state budget appropriation for state charter schools. Enrollments are disaggregated and detailed in Table 1 (attached).

Elm City Montessori School (ECMS), a local charter school, will enroll 102 students from the City of New Haven (through the local charter school program) and 11 students from suburban districts (through the Open Choice program) during the 2015-16 school year. Using the appropriate statutory per-pupil rate of \$3,000 for local charter schools, the seat request for ECMS is within the state budget appropriation during the 2015-16 school year. In accordance with C.G.S. § 10-266aa, New Haven Public Schools and ECMS entered into an agreement in 2014 to enroll ten percent of ECMS' students from suburban districts through the Open Choice program.

State Charter School Seat Proposals

Charter schools are listed below in three categories: (A) schools requesting waivers to increase enrollment beyond the statutory limit; (B) schools not requesting enrollment waivers; and (C) charter schools approved to open in the 2015-16 school year. This information is also summarized in the attached table.

A. Schools Requesting Waivers to Increase Enrollment

C.G.S. § 10-66bb(c)(1) places an enrollment cap on the number of students that a state charter school may enroll (300 seats for schools serving Grades K-8 and 250 for all other grade levels). The cap may be waived pursuant to C.G.S. § 10-66bb(c)(2) for those schools that have a demonstrated record of achievement. Schools must apply to the CSDE for permission to expand enrollment beyond the statutory limit. CSDE staff reviewed the applications and schools' records of achievement. Applications were received from: (1) Achievement First Bridgeport; (2) Achievement First Hartford; (3) Amistad Academy; (4) The Bridge; (5) Elm City College Preparatory School; (6) Highville Charter School; (7) Interdistrict School for Arts and Communication; (8) New Beginnings Family Academy; and (9) Park City Prep. The tables below show three-year School Performance Index (SPI) trend data for each charter school seeking a waiver to increase enrollment beyond the enrollment cap and the District Performance Index (DPI) for its respective host district.

1. Achievement First Bridgeport (AFB) (host district: Bridgeport)

The CSDE recommends granting an enrollment waiver to add 47 seats to the 2014-15 SBE approved enrollment of 968 students for a total of 1,015 seats. The requested seats are for expansion across existing Grades K-12. Achievement First Bridgeport has a strong record of student achievement, as illustrated below:

2. Achievement First Hartford (AFH) (host district: Hartford)

The CSDE recommends granting an enrollment waiver to add 101 seats to the 2014-15 SBE approved enrollment of 1,019 students for a total of 1,120 seats. This represents 59 seats for a new Grade 6, 33 seats for a new Grade 12, and nine additional seats for expansion in existing Grades K-5 and 7-11. Achievement First Hartford has a strong record of student achievement, as illustrated below:

3. Amistad Academy (host district: New Haven)

The CSDE recommends granting an enrollment waiver to add 52 seats to the 2014-15 SBE approved enrollment of 985 students for a total of 1,037 seats. The requested seats are for expansion across existing Grades K-12. Amistad Academy has a strong record of student achievement, as illustrated below:

4. The Bridge (host district: Bridgeport)

The CSDE recommends granting an enrollment waiver to add five seats to the 2014-15 SBE approved enrollment of 275 students for a total of 280 seats. The additional seats are for expansion across existing Grades 7-12. The Bridge has a demonstrated record of student achievement, as illustrated below:

5. Elm City College Preparatory School (host district: New Haven)

The CSDE recommends granting an enrollment waiver to add 61 seats to the 2014-15 SBE approved enrollment of 644 students for a total of 705 seats. The additional seats are for expansion across existing Grades K-12. Elm City College Preparatory School has a strong record of student achievement, as illustrated below:

6. Highville Charter School (host district: New Haven)*

The CSDE recommends granting an enrollment waiver to add 60 seats to the 2014-15 SBE approved enrollment of 400 students for a total of 460 seats. This represents 40 seats to expand to a new Grade 11 and 20 additional seats for expansion in existing Grades PK-10. Highville has a strong record of student achievement and academic improvement, as illustrated below:

7. Interdistrict School for Arts and Communications (ISAAC) (host district: New London)

The CSDE recommends granting an enrollment waiver to add eight seats to the 2014-15 SBE approved enrollment of 262 students for a total of 270 seats. The additional seats are for expansion across existing Grades 6-8. ISAAC has a strong record of student achievement, as illustrated below:

8. New Beginnings Family Academy (host district: Bridgeport)

The CSDE recommends granting an enrollment waiver to add 27 seats to the 2014-15 SBE approved enrollment of 470 students for a total of 497 seats. The requested seats are for expansion of the PK program. The school serves Grades PK-8. New Beginnings Family Academy has a strong record of student achievement, as illustrated below:

9. Park City Prep (host district: Bridgeport)

The CSDE recommends granting an enrollment waiver to add four seats to the 2014-15 SBE approved enrollment of 356 students for a total of 360 seats. The requested seats are for expansion across existing Grades 5-8. Park City Prep has a strong record of student achievement, as illustrated below:

B. Charters Not Requesting Enrollment Waivers

Six state charter schools requested seats under the statutory enrollment caps and do not require waivers for the 2015-16 school year. They include: Booker T. Washington, Brass City, Common Ground High School, Explorations, Great Oaks and Path Academy.

C. Charters Approved to Open in the 2015-16 School Year

Pursuant to previous SBE charter approval, the CSDE recommends approving 250 seats for Capital Prep Harbor and 168 seats for Stamford Charter School for Excellence.

Recommendation

The CSDE recommends that the SBE, pursuant to Section 10-66bb(c) of the Connecticut General Statutes, approve the distribution of 9,201 seats in state charter schools and 102 seats in a local charter school for the 2015-16 school year and grant enrollment waivers for nine schools, as delineated in this report.
