SUBJECT: Update on Students Displaced by Hurricanes

Executive Summary

Purpose

This presentation will provide updates regarding children and youth who have been displaced by hurricanes and arriving in Connecticut.

Background Information

In September 2017, Governor Dannel P. Malloy and Commissioner Dianna R. Wentzell issued guidance to school districts regarding enrollment of displaced children from Puerto Rico. The Connecticut State Department of Education has engaged in focused efforts to provide supports and technical assistance to school districts regarding the educational rights of students displaced by disasters.

As of December 1, 2017, 1,485 students have been enrolled in Connecticut schools as a result of being displaced. Approximately 64 school districts have reported one or more students. Eighteen districts have reported 10 or more students ranging from 10-291. Grade level data show the majority of students have enrolled in grades K-5 (51%), followed by 6-8 (23%) and 9-12 (23%). Forty-nine preschoolers have also been enrolled (4%). Most new arrivals have come from Puerto Rico.

Follow-up Activities

The CSDE is continuing to be responsive to the needs of districts as they work to enroll and stabilize children and youth in a new school experience. The State Board of Education's (SBE) continued engagement is important. Therefore, the CSDE will continue to provide updates to the SBE during this period of transition for districts and students.




- Case Management services are being coordinated by Salvation Army and Catholic Charities, based mostly on referrals from 211.

Total Number of Students Who Have Been Displaced -- Weekly Count




Locations of Origin of New Arrivals

 - Mexico (Earthquakes and Hurricane Katia)




Enrollment Locations of New Arrivals




Districts Receiving 10+ Students

Emerging News

- Federal Office of Management and Budget appropriation **request** to Congress
 - \$1.235 billion for hurricane education recovery
 - Includes funding for school districts and postsecondary institutions receiving students

Reported Challenges

- Space and capacity
- English as a Second Language certification shortage area
- Lack of academic records and placement challenges
- Identifying and accommodating students' special needs
- Lack of medical records and meeting medical needs
- Unaccompanied youth and legal guardianship
- Stress, trauma and mental health
- Material needs, e.g., school supplies and winter clothing
