Minutes of Meeting September 5, 2007

 - **SBE RETREAT:** The August retreat was very productive and lead to today's meeting regarding accountability and the presentation of the Cambridge Education Assessment.

- **OPENING OF SCHOOLS:** He met with the Superintendents and attended a number of school openings, did some radio spots and outreach efforts. He also sent out three circular letters on test results.
- SCHOOLS IN NEED OF IMPROVEMENT: He is working with the Superintendents and Board Chairs of the 12 districts in their fourth year of improvement.
- **HIGHVILLE:** The Highville Charter has been transferred to a new corporation that will assume all debts and build a budget and policies around that. The school will open at the old site for approximately 300 students.
- **READING SUMMIT:** There has been tremendous interest in the Reading Summit which is scheduled for November 2007. This summit will focus on how to close the achievement gap.
- Adequate Yearly Progress We received all reports on AYP. At the national level, Congress is reauthorizing the No Child Left Behind Act.
- Commissioner McQuillan congratulated Frances Rabinowitz, Associate Commissioner for the Division of Teacher, Learning & Instruction Leadership, on her new position as Superintendent of the Hamden Public School System.

Deputy Commissioner George Coleman introduced Jackee Bryant, Delta Sigma Thata, who is facilitating reading improvement at the local level.

- Legislation and Bylaws Committee Mrs. Bobroske reported that the General Assembly is still in Special Session concerning bond funds, Sheff and the budget. The committee set their meeting schedule for the coming year. The committee acknowledged the retirement of Mark A. Stapleton, Director, Division of Legal and Governmental Affairs, and commended him for all his work.
- **Policy Development Committee** Ms. Finneran reported that the committee will meet following today's regular meeting. They will review the Definition of Attendance, Policy Initiatives; Measuring Progress of the Board's Five-Year Plan and discussion of the Position Statement on Science Education.
- **Connecticut Technical High School Committee** Mr. Coolican reported that the next committee meeting is scheduled for September 12, 2007, at JM Wright Technical School in Stamford.
- **NASBE** Mrs. Bobroske congratulated Mr. Taylor on his appointment to the NASBE Board of Directors. He will be serving as the Area Director of the New England Region effective January 2008. The NASBE Board of Directors will be evaluating the Executive Director, Brenda Welburn. The National Conference is scheduled for October 10-13 in Philadelphia, PA. Mr. Taylor, Mrs. Bobroske and Dr. Voss will be attending.

• Ad Hoc Committee on Secondary Education. Mr. Voss reported that the committee met twice in August and they are still in the presentation mode. The committee has had presentations on the PK-16 Council, Career Path Initiatives and Connecticut Technical High School Models. The committee also reviewed other states endeavors regarding graduation requirements. Dr. Voss presented to the committee the beginning plan regarding what assessment might look like.
