Minutes

September 1, 2010, Meeting

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Wednesday, September 1, 2010. The meeting was held at the State Office Building, 165 Capitol Avenue, Hartford, Connecticut.

I. Call to Order

Chairperson Taylor called the meeting to order at 9:38 a.m.

Daniel P. Murphy, Legal Director, Legal and Governmental Affairs, administered the Oath of Office to William Fritz, member from Yalesville.

II. <u>Public Participation</u>

 Richard Cole, President and CEO, Connecticut Academy for Education in Mathematics, Science & Technology stated that the Academy offered its support for the State's plan with regard to Science. Math and Engineering; however, effort needs to be improved to show that learning is a responsibility. Mr. Cole invited the Board to join the October 21 CONNverge meeting at Rentschler Field.

- 2. Michael Savage, CEO, Jumoke Charter School and President Charter School Network, stated that the charters are not funded fairly or equitability. The Charters need advocacy by the State Board of Education and the Commissioner to ensure no public school student is left behind when providing money for students.
- 3. Marilyn Scanlon White, Legislative Chair, Connecticut Reading Association, supports one certificate for Literacy Specialist. Mrs. White's written comments can be found in the official file of this meeting.
- 4. Ann Marie Mulready, Visiting Professor at the university level, expressed concern with respect to the proposal for Language Arts certification. Dr. Mulready's written comments can be found in the official file of this meeting.
- 5. Lisa Lessard, parent from Waterbury, expressed concern with the Waterbury Public Schools providing her daughter special education services. Mrs. Lessard asked the Board to step in on her behalf.
- 6. Liz Cox, Director of Common Ground High School, expressed dismay at charter schools being excluded from the Education Job Funds Program.
- 7. D.J. Garcia, student at Common Ground High School, spoke in support of equal funding for charters.
- 8. Santiago Achinelli, student at Common Ground High School, pointed out the difference in funding between a public charter school and a public school.
- 9. Ralston Sessions, student at Common Ground High School, stated that funding should be increased for charter schools. The charter schools need to write grants in order to get support for education supplies.
