Minutes

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Friday, February 10, 2012. The meeting was held at the State Office Building, Room 307A, 165 Capitol Avenue, Hartford, Connecticut.

I. Call to Order

Chairman Taylor called the meeting to order at 9:40 a.m.

II. Public Participation

- 1. Abby Ray, student, Woodbury FFA, spoke to the Board about the need for funding to support agriscience education to accommodate those students interested in attending.
- 2. Robert Peterson, student, Woodbury FFA, spoke to the Board about the need for funding to support agriscience education and the benefits of the program in relation to his career aspirations (environmental law).
- 3. Christa Roth, Student, Woodbury FFA, described her interest in plant genetics and the rigor of the courses offered at Nonnewaug High School.

- 4. Jennifer Ayers, student, Woodbury FFA, spoke to the Board about the need for funding to support agriscience education.
- 5. Collin Sieracki, former student, Woodbury FFA, spoke to the Board about the need for funding to support agriscience programs, and the benefits of the program to his professional career as the owner of a landscaping business.
- 6. Dave Golembeski, former student, Woodbury FFA, spoke to the Board about the value of the program in terms of preparing him for a career in golf course management.
- 7. Kathryn Golembeski, State Agriscience Advisory Committee, spoke in support of increasing opportunities for students to enroll in agriscience programs, and expressed her concerns about sending schools not encouraging students to consider agriscience, due to the negative financial impact on the sending districts.
- 8. Robert Klancko, New Haven Manufacturers Association, spoke to the Board about the need for financial and in-kind support for agriscience programs and their integral role in the STEM fields (science, technology, engineering and mathematics).
- 9. Jody Goeler, Superintendent of Regional School District No. 14, spoke to the Board about the inequities in funding for the various choice programs and urged the Board to support equitable and adequate funding for vocational agriculture.
- 10. Bob Heffernan, Executive Director of Connecticut Green Industries, stated that the funding structure for vocational agriculture is a disincentive to districts.
- 11. George Wheeler, State Agriscience Advisory Board, spoke about the inequities of funding for vocational agriculture.
- 12. Jaunice Edwards, Director of Harris Agriculture Center in Bloomfield, expressed her support for properly funding the agriculture programs, and valuing the achievement of the students enrolled in these programs.
- 13. Bill Davenport, Director of the Nonnewaug Vocational Agriculture Program, spoke to the Board about the need for skilled workers in this industry. He noted, however, that we are required to turn away students due to inadequate funding for vocational agriculture, resulting in "importing" workers.
- 14. Michael Carlo, citizen, spoke to the Board about the need to be responsible and accountable for ensuring proper certification of Connecticut's educators.

- 15. Andrea Johnson, President of the Hartford Federation of Teachers, expressed concerns that the Performance Evaluation Advisory Committee did not consider the impact of poverty on education (e.g., child's vocabulary, exposure to opportunities) and how that contributes to an uneven playing field for teachers and students.
- 16. Jerald Cole, Instructional Technologist, described a study on the Carnegie Unit and the actual amount of time spent on learning.

A. Presentation by members of Project Opening Doors

Cam Vautour, President, Project Opening Doors; Paula Colen, Executive Director, EASTCONN; Carmen Cid, Dean of Arts and Science, Eastern Connecticut State University; and Jean Purcell, Principle Investigator, Step2STEM, presented an overview of Project Opening Doors, a statewide Advanced Placement initiative. Discussion followed.

The Board recessed its meeting at 12:05 p.m.

VIII. Connecticut Technical High School Matters (CTHSS)

A. Report of the Superintendent

- Superintendent Ciccone noted that CTHSS has received legislative approval for a bond authorization of \$28 million in each year of the biennium. The CTHSS began fiscal year 2012 with an unauthorized bond balance of \$3.8 million from prior fiscal years.
- CTHSS has the potential to receive up to \$31.8 million in bonding during the current fiscal year.
- To date, CTHSS has received Bond Commission authorization for \$8.4 million of the possible \$31.8 million.
- CTHSS is currently recruiting for 9th grade. The system has received 7,800 applications.
- Eli Whitney, Ellis Tech, O'Brien and Wright are school construction projects that are moving forward.
