V. Report of the Chair

Chairman Taylor reported the following:

Commissioner Pryor's Confirmation

On February 28, 2012, the Senate, by a unanimous vote, confirmed Commissioner Pryor as the Commissioner of Education.

Educator of the Year Award

Mr. Taylor extended congratulations to Commissioner Pryor who has been selected as the "Educator of the Year" by the Turkish Cultural Center. The Commissioner will be recognized tomorrow evening at the 2012 Friendship Dinner at the Marriott Hartford Downtown, sponsored by the Cultural Center and the Peace Islands Institute. The theme of the event is "Poverty, Hunger and Obesity." The keynote speaker is Dr. Kelly Brownell of Yale University Rudd Center for Food Policy and Obesity. Other distinguished guests include Congressman Chris Murphy, Governor Malloy, Senator Steve Cassano, and Quinnipiac University President John Lahey.

Governor Malloy's Education Reform Tour

Board members are welcome to attend any of the Governor's Education Reform Tour sessions. This past week, Governor Malloy held a forum in Hartford and another in West Hartford. Additional forums are being scheduled across the state to discuss his education reform proposals. The Governor will be joined by Lieutenant Governor Nancy Wyman and Commissioner Stefan Pryor.

Hearings on Charter School Renewal Applications

Hearings have been scheduled to review the renewal applications of seven charter schools. Mr. Taylor thanked those Board members who have volunteered to chair the hearings to consider the renewal of the following applications: Amistad Academy; Elm City Charter School; Achievement First Bridgeport; Jumoke Academy; Stamford Academy; Trailblazers Academy; and Bridge Academy.

VI. Report of the Commissioner

Commissioner Stefan Pryor reported that staff members have been available to legislators throughout the legislative session. Meetings held to date include a February 21 meeting of the Appropriations and Education Committees; a meeting of the Education Committee on February 22; a subcommittee meeting of the Appropriations Committee and Education Committee meeting on February 28, and an Education Committee meeting on March 5.

The Commissioner noted that he and key staff members have been asked for their input throughout the process and that he has given testimony at public hearings.

X. Items Requiring Action

A. Establishment of and Charge to Educator Preparation Advisory Council

Mr. Wright moved, Dr. López seconded, that the State Board of Education authorizes the Commissioner of Education, working with the President of the Board of Regents for Higher Education (or their designees), to take necessary action to establish the Educator Preparation Advisory Council (EPAC) to advise the State Board of Education in developing a system for the approval, quality, regulation, oversight, and accreditation of Connecticut educator preparation programs—including but not limited to performance in the classroom as determined by indicators such as teacher evaluations and student achievement data; program graduates' retention, turnover, and dismissal rates in their schools; new graduates' preparation for work in high-need districts; the effectiveness of the preparation programs' recruitment efforts among top tier university students; and structured feedback from school districts on the readiness and effectiveness of preparation program graduates— with the intention of:

- better preparing teachers and school leaders;
- ensuring educator preparation programs are well-aligned with the needs of Connecticut's schools and districts:
- recommending reforms to the state's educator certification regulations so that state policies align with an outcome-based system of accreditation and oversight;
- establishing rigorous standards for acceptance into teacher and administrator preparation programs; and
- meeting objectives articulated in the materials presented to the State Board of Education.

The Council will meet over the next year as determined by the Co-Chairs and Council. The Council will provide updates to the P-20 Council once per quarter throughout the year they meet in an informational capacity. The Co-Chairs of the Council will present the overall recommendations to the State Board of Education for consideration and further action by April 2013.
