Commissioner Pryor stated that Marianne Kirner, Executive Director of SERC, was very involved in the development of this proposal and, although unable to attend today's meeting, wanted to state for the record her support of the SERC governing board representing the racial and cultural make-up of Connecticut's student population, and her hope that the SERC board represent multiple perspectives, including education.
