Minutes of the July 15, 2013, State Board of Education Meeting (approved September 4, 2013)

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Monday, July 15, 2013, in Room 1D of the Legislative Office Building, Hartford, Connecticut.

I. Call to Order

Attorney Laura Anastasio administered the Oath of Office to Clayton Potter, Student Member of the State Board of Education

II. Public Participation

- 1. Eliza Halsey, New Haven, spoke in support of the Board's approval of the local charter school application for Elm City Montessori School in New Haven.
- Maegan Parrott, New London Parents Advocates, New London, expressed her concerns regarding the need for the continued role of Special Master Adamowski in New London, and urged the Board to restore the local school board to full autonomy. A copy of Ms. Parrott's prepared remarks is contained in the official file of this meeting.
- 3. Jason Morris, parent, New London, expressed his concerns regarding the lack of transparency throughout the budget process, and the impact on New London Public Schools under the leadership of the superintendent and Special Master.

Connecticut State Board of Education Meeting Minutes of Meeting

Mr. Taylor noted that he would like removed from the agenda item VI.F., Commissioner's Network Plan: Crosby High School, Waterbury. He also noted that item IV.B., pending litigation (Carmen L. Lopez et al. v. Paul Vallas) should be removed from Executive Session and, instead, added to the agenda as an item requiring action.

On a motion by Mr. Jaskiewicz, seconded by Mr. Wright, the Board voted unanimously to add to the agenda, item VI.M., Resolution to Authorize the Commissioner to Request on its Behalf, that the Attorney General Present the Board's and Commissioner's Concerns With the Court's Determination and Prior Decisions in the Matter of Lopez v. Vallas.

A. Approval of Application for Funds: Chief Council of State School Officers (CCSSO)

- Appoints Ann F. Bird, R. Thomas Clark, Donal C. Collimore, Janis C. Jerman, Stanton H. Lesser, Thomas C. McNeill, Jr., Mary E. Oppenheim, Steven R. Rolnick and Frederic S. Ury to the Impartial Hearing Board for a one-year term beginning August 9, 2013;
- 2. Authorizes the Commissioner of Education to designate, as appropriate, on or more persons from the Impartial Hearing Board to conduct hearings as required; and
- 3. Directs the Commissioner of Education to take the necessary action.

D. Establishment of Cut Score for Praxis II Health Board

RESOLVED, That the State Board of Education establishes, in accordance with Subsection (b) of Section 10-145f of the Connecticut General Statutes, a new cut score of 164 for the Praxis II Health Education (#5551) due to a change in the scoring scale, effective September 1, 2013, and directs the Commissioner to take necessary action.

- The school must address the State Fire Code violations detailed in the Site Visit Committee's Report before August 31, 2013 (prior to the 2013-2014 school year);
- PSA shall notify the Division of Legal and Governmental Affairs upon correction of the safety issues and verification by the local fire marshal;
- In the event that PSA cannot complete the remediation before August 31, 2013, PSA shall provide the reasons for the delay and a timeline for such remediation, which shall be subject to the approval of the Commissioner;

and directs the Commissioner to take the necessary action.

Vallas to raise significant issues of public interest regarding the future of the Bridgeport schools and the authority of the State Board of Education and Commissioner, and one that merits an expeditious review. The Board directs that the Commissioner, on its behalf, request, regarding any appeal or other review of the trial court decision in Lopez v. Vallas, that the Attorney General take such steps as he deems appropriate and necessary to present the Board's and Commissioner's concerns with the court's determinations regarding the authority and prior decisions of the Board and the Commissioner in regards to Bridgeport Acting Superintendent Vallas.
