# Draft Minutes of the September 4, 2013, State Board of Education Meeting

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Wednesday, September 4, 2013, in Room 1D of the Legislative Office Building, Hartford, Connecticut.

### I. Call to Order

Attorney Matthew Venhorst administered the Oath of Office to Jake Colavolpe, Student Member of the State Board of Education.

# II. Public Participation

- 1. Dr. John Zack, Associate Director of Teacher Education, Neag School of Education, University of Connecticut, expressed concerns regarding Section 36 of P.A. 12-116, which requires an applicant for a professional educator certificate, on and after July 1, 2016, to hold a master's degree in an appropriate subject matter area related to such person's certification endorsement area. A copy of Dr. Zack's prepared statement is included in the official file.
- Doreen Richardson, Chair, Windsor Board of Education, thanked the Board for Alliance District funding. She discussed a 2013 report titled "Excellence and Equity: The Impact of Racial Inopportunity on Student Development and Achievement at Windsor High School," prepared by "Loyola University-Chicago and Loyola University-Maryland," which was supported by the Alliance grant funds.

- 4. Ben Wenograd, Field Representative with AFT Connecticut who has represented the Windham Federation of Teachers for the past 13 years, spoke on behalf of Randall Prose, union president of WFT. Mr. Wenograd spoke about the achievement levels of Windham Public School students under Dr. Adamowski's leadership as Special Master. A copy of Mr. Wenograd's prepared statement is included in the official file.
- 5. Kevin Basmadjian, Dean of the School of Education at Quinnipiac University, expressed his thoughts on the proposed requirements concerning the Professional Educator Certificate, highlighting both opportunities and potential unintended consequences. A copy of Mr. Basmadjian's prepared statement is included in the official file.

# D. Policy for Implementation of New Statutory Requirement for Master's Degree in an Appropriate Subject Area to Qualify for a Professional Educator Certificate

Dr. Barzee, Chief Talent Officer, Mrs. Nancy Pugliese, Chief, Bureau of Educator Standards and Certification and Mrs. Georgette Nemr, Education Consultant, Bureau of Educator Standards and Certification, presented a powerpoint presentation on the implementation of new statutory requirements in order to qualify for a Professional Educator Certificate. Discussion ensued.

The three members of the Board's Academic Standards Committee will attend (Allan Taylor, Steve Wright and Theresa Hopkins-Staten.)

The State Board of Education has been invited to meet with the CABE Board of Directors Meeting on September 12 at 5:00 p.m. at CABE Headquarters in Wethersfield. Pat Keavney-Maruca, Steve Wright, Joe Vrabely and Bob Trefry have indicated that they will attend.

### IX. Report of the Commissioner

Commissioner Pryor thanked Mr. Taylor and Mrs. Keavney-Maruca for attending the Superintendent's Back-to-School meeting. Many important topics were discussed at the meeting, including Common Core standards, evaluation, turnaround efforts, nutrition, and student suspensions. The Commissioner informed the Board of his visits to school districts across the state, noting that he has spoken at convocations or similar assemblies in Norwich, Wallingford, New Haven and the Technical High School System. Mr. Pryor added that he will continue such visits in the coming weeks.

Commissioner Pryor informed the Board that six Alliance District plans have been approved to date (Bloomfield, Danbury, East Hartford, Hamden, West Haven, Windsor Locks) and that two have been given partial approval, pending further discussions and revisions to their plans (Ansonia and Norwich). Partial approval results in the authorization of certain Alliance District funds to begin reform initiatives, with the expectation that, through an iterative process, the remainder of the application will warrant full approval.

# F. Technical High School System (THSS) Board

Mr. Trefry reported on several topics considered by the Technical High School System Board, including a fiscal update; school security plans; the awarding of a contract to Thomas Miller Associates to develop a strategic plan in concert with the Board; the resubmission of a RFP for a consultant to conduct a search for a permanent Superintendent of Schools; and discussions with the Office of Policy and Management regarding hiring an assistant superintendent and upgrading positions to be more competitive. Mr. Trefry noted that the welding program at Groton is moving forward, and that discussions are underway with the Board of Regents to improve the use of school facilities.

No report was given.

### Other

Mrs. Hopkins-Staten suggested that the Board invite Professor Marlon James to an upcoming meeting to discuss the findings of his report on cultural differences in the Windsor School System.

Ms. Comer announced the passing of Hartford legend, Mrs. Trude Mero, an advocate for justice, children and education.
