Minutes of the March 5, 2014, State Board of Education Meeting (approved April 2, 2014)

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter *"Board"*) met on Wednesday, March 5, 2014, in Room 307, State Office Building, 165 Capitol Avenue, Hartford, Connecticut.

I. Call to Order

II. Public Participation

VIII. Report of the Chair

Mr. Tayor thanked Mrs. Keavney-Maruca, Mr. Wright and Mr. Vrabely for chairing the upcoming four charter school hearings in Bridgeport, Stamford and New Haven. These charter school applications will be submitted to the Board for approval at the April 2, 2014, State Board of Education meeting.

<u>Winchester 10-4b Matter</u>: The Winchester parties have reached an agreement in the 10-4b Matter, which will be submitted to the Board on April 2, 2014, for its consideration.

NASBE has confirmed speakers for its annual Legislative Policy Forum this March:

- Federal Communications Commissioner Jessica Rosenworcel will discuss broadband access and delivery to schools;
- Libby Doggett, Deputy Assistant Secretary for Policy and Early Learning at the U.S. Department will present on high quality early learning opportunities; and
- Hedy Nai-Lin Chang joins a panel on establishing positive conditions for learning.

Education Secretary Arne Duncan will deliver the closing keynote address. Mr. Taylor will attend the NASBE Study Group on Student Engagement, and Mr. Wright will attend the Legislative Policy Forum.

IX. Report of the Commissioner

Commissioner Stefan Pryor updated the Board on the Legislative Session to date. The Session began on February 5. Governor Malloy delivered his budget address on February 6. The Appropriations Committee met on February 24, followed by a workgroup session which focused on K-12 education. On February 28, the Education Committee held an informational forum, which was attended by the Commissioner, the Council of Chief State School Officers, and other experts who presented testimony regarding the Common Core. An initial public hearing on education bills was held on March 3. Our primary focus during this Session is on ensuring that the budget for K-12 education is fulfilled, Commissioner Pryor reported.

X. Financial Matters

A. Budget Update

Commissioner Pryor and Interim Chief Financial Officer Kathleen Demsey highlighted the Midterm Budget Adjustments; a copy of the related PowerPoint presentation is included in the official file of this meeting.

XI. Committee Reports

A. Academic Standards and Assessment

Mr. Wright referenced a written report that was included in the Board's materials. He held an informal meeting with Dr. Dianna Roberge-Wentzell to informally discuss the current goals and objectives of the Committee and set a schedule of meeting dates for the coming months, to include discussions of the science standards and implementation of the Common Core State Standards. Mr. Wright reported that he and Mr. Jones have met with representatives of the Connecticut Society of Social Studies Teachers regarding the drafting of a mission statement and related standards for social studies, under the supervision of Dr. Roberge-Wentzell. Mr. Wright was pleased that the position of Social Studies Consultant has been filled. The first meeting will be on April 17, 2014; both science and social studies will be considered.

The Board discussed how to improve communication about the Common Core, including how to clarify misunderstandings, and its advocacy role in this regard. Mr. Taylor noted that he will communicate the Board's commitment to the Common Core State Standards during the upcoming hearing before the Education Committee of the General Assembly, and encouraged Board members to promote it in every appropriate forum. commitment to the Common Core State Standards in Connecticut, and disseminating it to media across the state.

B. Accountability and Support

C. Finance, Audit, and Budget

Mr. Taylor reported that the committee met recently, and the work of the Office of Internal Audit is going along smoothly.

D. Legislation and Policy

Mrs. Hopkins-Staten stated that the committee met this morning and received an update on topics and bills raised to date. She noted that the Department has been working collaboratively with the Center for Children's Advocacy. The committee also received and discussed the *Report on the Analysis of School Districts' Efforts Regarding the Prevention of and Response to Bullying in Schools.* A copy of the report will be provided to the full Board.

E. Connecticut Technical High School System Board appointments

Mr. Trefry noted that the CTHSS Monthly Newsletter will be sent to Board members. He noted that the system has hired a principal of J.M. Wright Technical High School, which will be opening in September 2014. He also reported on a meeting with the Office of Policy and Management to discuss budget expansion, and OPM's support for auto-refills of positions, including staff for Wright Tech and additional maintainers in school buildings. Mr. Trefry reported that the Board held its retreat and will soon be sending the draft strategic plan for comment.

F. NASBE

Mr. Wright will attend the March Legislative Conference.

Mr. Jones reported on the NASBE School Health Grant Site Visit, held on February 28, 2014, and collaborative initiatives with other state agencies and organizations. He commented on the direct relationship between student health and academic achievement.

By unanimous consent the meeting was adjourned at 12:36 p.m.
