Minutes of the May 7, 2014, State Board of Education Meeting (Approved June 4, 2014)

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Wednesday, May 7, 2014, in Room 307, State Office Building, 165 Capitol Avenue, Hartford, Connecticut.

I. Call to Order

Chairperson Allan Taylor called the meeting to order at 9:40 a.m.

II. Public Participation

- Jeffrey Villar, Connecticut Council for Education Reform (CCER), commented on proposed changes to PEAC, noting that teachers have opportunities to weigh in on their goals, and deserve feedback on their performance. Mr. Villar described the link between instruction and student performance.
- 2. Agnes Burns, president of the Connecticut Association for Reading Research, spoke about the definition of reading, and the need to establish a clear purpose for the assessment of young readers. A copy of Ms. Burns' prepared remarks is included in the official file of this meeting.
- 3. Dr. Ann Marie Mulready, Connecticut Association for Reading Research, expressed her concerns about the assessment of K-3 literacy. A copy of Dr. Mulready's prepared remarks is included in the official file of this meeting.

- 4. Jennifer Alexander, Chief Executive Officer, Connecticut Coalition for Achievement Now, expressed her views on the proposed revisions to Connecticut's statewide system for educator evaluation, noting that while compromises might be in order, it is important that any modifications to the state's educator evaluation system must ensure that we preserve the link between an educator's performance review and achievement growth. A copy of Ms. Alexander's prepared remarks is contained in the official file of this meeting.
- **5.** Tom Stringfellow, resident of Manchester, spoke about the importance of earth science and geography, the Common Core State Standards, and recommended to the Board several articles and books regarding slavery and progress in the Manchester Public Schools.

Commissioner Stefan Pryor made a preliminary announcement regarding the 2013 NAEP results in reading and mathematics, highlighting Connecticut's successes in reading, mathematics and closing the gap.

- 6. Michael Galluzzo, Assistant Executive Director, Connecticut Principal's Center of the Connecticut Association of Schools, spoke about alternative school programs and CAS' role in working with a large group of urban educators and legislators on how best to attract these underserved students in significant numbers. He noted that the recommendations in the Achievement Gap Task Force Master Plan provide a comprehensive approach to preparing all students to be college and career ready, and urged the Board to advocate for policies and legislation in support of the Master Plan. A copy of Mr. Galluzzo's prepared remarks is included in the official file of this meeting.
- Rosa Torres, a parent of a child attending Luis Muñoz Marin School in Bridgeport, described her
 role in developing the Turnaround Plan for the school. She urged the Board to approve the
 plan.
