# Draft Minutes of the June 4, 2014, State Board of Education Meeting

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter *"Board"*) met on Wednesday, June 4, 2014, in Room 1D of the Legislative Office Building, Hartford, Connecticut.

#### I. Call to Order

#### II. Public Participation

- Dr. Darcy Fiano, public school educator who works in an Alliance district involved in the K-3 Literacy Initiative, parent, and a researcher, expressed concerns regarding the K-3 Literacy Initiative with regard to the Department's lack of focus on oral language acquisition and development. Dr. Jess House, Dean of the School of Professional Studies at Western Connecticut State University, spoke in support of the Board adopting the AACTE-CT proposal, wherein courses in an appropriate master's degree must be related to the teacher's certification endorsement area. # A. Achievement Gap Taskforce Master Plan to Eliminate the Achievement Gap in Connecticut

Mrs. Charlene Russell-Tucker, Chief Operating Officer, introduced Mr. Miguel Cardona, Performance Evaluation Specialist, Meriden Public Schools, and Co-Chair of the Achievement Gap Task Force; and Mr. Steven Hernandez, Public Policy Director for the Connecticut Commission on Children. Mr. Cardona and Mr. Hernandez presented a summary of the work of the Achievement Gap Taskforce and the findings and recommendations contained in its report, "Achievement Gap Taskforce Master Plan to Eliminate the Achievement Gap in Connecticut."
