Minutes State Board of Education Meeting September 3, 2014

(Approved November 5, 2014)

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Wednesday, September 3, 2014, in Room 1D of the Legislative Office Building, Hartford, Connecticut.

I. Call to Order

Chairman Allan Taylor called the meeting to order at 9:45 a.m.

Attorney Louis Todisco administered the Oath of Office to State Board of Education members Erin D. Benham and Maria I. Mojica, and student members Michael Caminear and Megan Foell.

II. Public Participation

- Bette Bergeron, Provost and Vice President for Academic Affairs, Southern Connecticut State University (SCSU), asked the Board to consider granting provisional approval, as opposed to probationary approval to the SCSU educator preparation programs. She expressed her confidence in the ability of the new Dean of the School of Education, Stephen Hegedus, to respond to and remedy areas identified as needing improvement by the end of this academic year.
- 2. Stephen Hegedus, Dean of the School of Education, Southern Connecticut State University, expressed his commitment to continuous improvement at the university's educator preparation program, and his confidence in completing the work that needs to be done to address identified "areas for improvement" (AFIs)

- within the year. He stated that he does not think the current recommendation of probationary approval accurately reflects the progress already made toward correcting the AFIs.
- 3. Sonya Kunkel, Program Administrator of the Capitol Region Education Council (CREC) Advanced Alternate Route to Certification (AARC) for special education cross-endorsement, stated that efforts to correct AFIs identified in the AARC are underway. She said that CREC will provide a full round of performance data to Dr. Katie Toohey, the Program Approval Coordinator at the State Department of Education's Bureau of Educator Standards and Certification, at the in September 2015. A copy of Ms. Kunkel's prepared remarks in enclosed in the official file of this meeting.
- 4. Attorney Corey Brinson, representing his client Dr. Joseph H. Johnson, expressed his support for allowing Dr. Johnson to serve as an educational administrator in Connecticut, and noted that he disagrees with the State Department of Education's interpretation of the regulatory language regarding educator certification (agenda item VI.C.).
- 5. Dr. Joseph H. Johnson addressed the Board regarding agenda item VI.C., Petition for Declaratory Ruling, and stated that he would like the opportunity to impact the lives of students within the New Haven Public School System, and asked the Board to help him find a pathway for certification to enable him to do so.
- 6. Cheryl Marceau reported on an article in the Bradley County News on August 20, 2013, "Common Core Lesson Plans." She expressed her opposition to the Common Core and to public schools promoting a religion to students, and invited the Board to attend a fact finding session regarding the Common Core on October 5. A copy of the news article is enclosed in the official file of this meeting.
- 7. Gwen Samuel, parent advocate, spoke about the need for parental engagement, especially as the school year begins. Ms. Samuel stated that the Board must promote equal educational opportunities and protect the interests of all children. She recommended that the Board review policies related to student attendance.
- 8. Bob Hannafin, AAACTE CT, Fairfield University, thanked Commissioner Pryor for his service in Connecticut and extended his wishes for continued success in his future endeavors.
- 9. Kathy Cordone, retired teacher, expressed her concerns about the Common Core, stating that there is no evidence to support the claim that the Common Core will result in college- and career-readiness. She added that academic standards should be developmentally appropriate and developed by Connecticut teachers.
- 10. Lisa Lessard, resident of Waterbury, addressed the Board on the Walsh School Turnaround Plan. She urged the Board to closely monitor the activities of Waterbury school officials, and to review data regarding how funds are used and whether programs are successful. She expressed her concern with a practice

- within the Waterbury school district that had required special education students to earn locker privileges.
- 11. Athena Wagner, resident of Waterbury, addressed the Board regarding the Walsh School Turnaround Plan. She stated that there needs to be strict oversight of funds given to Waterbury and a close examination of data to ascertain whether funds are being used effectively. Among concerns she raised were an increase in disciplinary incidents, student performance as indicated by the School Performance Index, and school governance councils not being in compliance. Ms. Wagner distributed a memorandum to the Board regarding school leadership in the Waterbury Public Schools (copy in official file).
- 12. Kelt Cooper, Superintendent of the New Britain Public Schools, discussed successful efforts and programs within his school district that have resulted in a reduction of the truancy rate, a reduction in in- and out-of-school suspensions, an increase in academic achievement, and better addressing the needs of English language learners. Superintendent Cooper noted that his district has benefitted from its partnership with the Department, and he commended and thanked Commissioner Pryor and the Department for their partnership.
- 13. James and Sandra Baker, parents of a former Hartford Magnet Trinity College Academy student, expressed their concerns about their daughter's demeaning experience when attending a Nature's Classroom field trip in 2012, particularly, the Nature's Classroom slavery reenactment exercise that neither the parents nor their daughter had any prior knowledge about and in which their daughter participated. They expressed their concern that Connecticut students continue to participate in Nature's Classroom program. A copy of Mr. and Mrs. Baker's prepared remarks is enclosed in the official file of this meeting. [Note: Later in the meeting, Mrs. Hopkins-Staten asked what steps could be taken to ensure that the type of experience in Nature's Classroom, as described by Mr. and Mrs. Baker, is not encountered by future participants. Commissioner Pryor responded that the Department would look into this matter and will report back to the Board.]
- 14. Carroll E. Brown, mother of Eric T. Brown, who served as principal of Walsh School in Waterbury, expressed concerns regarding Waterbury Public Schools and the conclusion of Mr. Brown's tenure as principal.
- 15. Dr. Ann Marie Mulready, Connecticut Association for Reading Research, read a prepared statement regarding concerns with the K-3 statewide literacy assessment plan, including (1) the list of assessments in the final plan and (2) the policy implications in relation to the law. A copy of Dr. Mulready's statement is enclosed in the official file of this meeting.

IX. Report of the Commissioner

2014 Back-to-School Conference

Commissioner Stefan Pryor reported on his Back-to-School Conference for Connecticut's superintendents, held at the Legislative Office Building on August 19, 2014, attended by 140 superintendents, guests and staff members. Lieutenant Governor Nancy Wyman made opening remarks. Commissioner Pryor spoke about the survey administered to superintendents last May and how the Department is responding to the needs identified by superintendents in several areas (including Common Core Standards, teacher evaluation, professional development needs, and technical assistance). He referenced several publications that were produced in response to the survey and each superintendent was provided a packet. Commissioner Pryor also spoke about early signs of progress evident statewide, the necessity of a well-rounded education for students, and the integral role of the arts in education.

Update on Booker T. Washington Academy

Commissioner Pryor asked Mr. Morgan Barth and Mr. Mark Linabury to give a status report on Booker T. Washington's readiness to open. The details of this report are contained in Mr. Barth's September 3, 2014, memorandum to the State Board of Education.

X. Financial Matters

A. Current Services and Capital Budget Request for 2015-16 and 2016-17

Ms. Kathleen Demsey, Chief Financial Officer, reported that despite a \$20 million negative balance in the magnet school account, the 2013-14 agency budget closed out with a \$4.8 million surplus.

She stated that she will be presenting the current services budget for the coming fiscal year at the Board's October 1, 2014, meeting. Expansion and reduction options will also be presented in accordance with guidance from the Office of Policy and Management.

XI. Committee Reports

A. Academic Standards and Assessment

No report was given.

B. Accountability and Support

Dr. López reported that the committee met on July 30, 2014. Mr. Barth gave a detailed overview of the status of the Commissioner's Network Schools and Alliance Districts.

C. Finance, Audit, and Budget

Mr. Taylor reported that the committee met on August 21, 2014, and considered several matters, including the Annual Audit Plan. He noted that a copy of the plan was forwarded to members of the Board in the weekly mailing.

D. Legislation and Policy

Mrs. Hopkins-Staten reported that the committee met prior to today's Board meeting, and received a presentation by New Britain Superintendent of Schools Kelt Cooper on his district's successful efforts to reduce chronic absenteeism.

E. Connecticut Technical High School System Board

Mr. Trefry stated that he was pleased with the reopening of J.M. Wright Technical High School in Stamford.

F. NASBE

Mr. Taylor reported on NASBE under his report earlier in the meeting.
