# CONNECTICUT STATE BOARD OF EDUCATION Hartford

Minutes
State Board of Education Meeting
July 1, 2015
(approved September 2, 2015)

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Wednesday, July 1, 2015, in Room 1D of the Legislative Office Building, 165 Capitol Avenue, Hartford, Connecticut.

#### I. Call to Order

## Oath of Office

## II. Public Participation

- 1. Justin McGlamery, a parent of a Renzulli Academy student, expressed his concerns regarding Renzulli Academy students being moved from their building and explained the negative impact on the students. He also stated his concerns about the lack of play space at the Washington Street location, the lack of security at that site, and not receiving accurate information from the Hartford superintendent.

Goff, parent of a Renzulli Academy student, expressed her concerns about the lack of transparency on the part of the Hartford superintendent and her staff, funding issues related to the school, and her disappointment that the school has not been supported or acknowledged for its success.

4. Shontá Browdy, parent of a former Renzulli Academy student, stated her concerns about conditions in Hartford's schools, including PCBs at Clark School and overcrowding at Wish School. Ms. Browdy stated that Renzulli Academy needs to be recognized for its achievements, and expressed her support for real parental engagement where parents are respected and valued.

Dr. López moved, Mr. Vrabely seconded, that the State Board of Education, pursuant to Section 10-145d-9(g) of the Regulations of Connecticut State Agencies, grants an extension of approval for educator preparation programs scheduled for continuing approval visits during the academic years 2015-2016 and 2016-2017 and imposes policy restrictions on new program proposal applications, limiting them to only those that can demonstrate an enrollment base of 10 or more candidates per year and can specifically address the Connecticut State Department of Education designated shortage areas as reported by the Department in the 2015-2016 and 2016-2017 academic years, and directs the Commissioner to take the necessary action.

directs the Commissioner to take the necessary action, including, but not limited to, expending such funds as may be necessary to execute and implement the foregoing.

- o Mrs. Hopkins-Staten addressed all employees of the State Department of Education at the June "all staff meeting" held at Rentschler Field in East Hartford.

# IX. Report of the Commissioner

Commissioner Wentzell referred to her printed report, and highlighted the following points:

- The Connecticut State Department of Education has been interacting with the United States Education Department (USED) on Connecticut's ESEA flexibility request; Connecticut's formal request to move to a college-readiness assessment for Grade 11 students; and a conference call with USED Secretary Duncan and chief state school officers on Smarter Balanced and PARCC assessments, including concerns about how to communicate and ensure that parents understand the scores. Commissioner Wentzell noted that Connecticut is trying to develop a reporting format for SBAC similar to what parents have been accustomed to in the past (CMT report).
- o Laura Stefon, the SDE legislative liaison, is preparing a summary of the 2015 legislative session in relation to education. She informed the Board that legislation authorizing the Commissioner to appoint a receiver for the Winchester Public Schools had been approved and that the receiver would be appointed by August 1, reporting directly to the Commissioner. The Commissioner will share an executive summary on this matter with the Board.
- SDE staff greatly appreciated Vice Chairperson Hopkins-Staten's participation and thoughtful comments at the recent "all staff" meeting. The Board will receive a summary of the feedback offered by SDE employees.
- The Annual Back-to-School Meeting with Superintendents and education partners is scheduled for August 19, 2015, at A.I. Prince Technical High School in Hartford, and Board members are welcome to attend.
- Mini-grants to districts, awarded in the 2014-15 school year, have been well received by districts. Commissioner Wentzell noted that she had the pleasure of attending an event at Mattatuck Museum in Waterbury, and will send a link to the event to Board members.

#### X. Financial Matters

Chief Financial Officer Kathy Demsey reported on the 2015 Special Session of the General Assembly. She noted that the Department's budget is approximately \$3.1 billion, and summarized the impact on the Education Cost Sharing grant, Alliance Districts, charter school account, magnet schools, bilingual education, talent, and the CTHSS.
