Minutes State Board of Education Meeting September 2, 2015 (approved October 7, 2015)

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Wednesday, September 2, 2015, in Room 1D of the Legislative Office Building, 300 Capitol Avenue, Hartford, Connecticut.

I. Call to Order

- II. Public Participation

- VII. Items for Discussion
 - A. Update on Connecticut English Language Proficiency Standards

Ellen Cohn, Deputy Commissioner for the Implementation of Education Reform, and Megan Alubicki-Flick, ESL/Bilingual Consultant, Academic Office, presented the report and gave a PowerPoint presentation to the Board (copy enclosed in official file). Discussion ensued.

B. Overview of 2015 Legislative Session

Laura Stefon, Legislative Liaison, provided a summary of legislation passed during the 2015 Session of the General Assembly, and described the timelines for submitting proposals for the 2016 legislative session. She noted that the Legislation and Policy Development Committee will discuss proposals at the October committee meeting, and proposals will be submitted to the full Board for consideration in November.

VIII. Report of the Chair

Vice Chairperson Theresa Hopkins-Staten referred Board members to the "Report of the Chair" in the Board's supplemental materials folder, which includes a summary of the following matters:

- The Developing Tomorrow's Professionals will host a breakfast at the Aqua Turf Club on September 21, 2015, at 8:30 a.m. Mrs. Hopkins-Staten encouraged Board members to attend;
- Stephen Wright will serve as a voting member on the Mastery Examination Committee. The Committee is scheduled to meet on September 22, 2015; and
- The <u>2015 Annual NASBE Conference</u> will be held October 22-24, 2015, in Baltimore. Mr. Taylor, Mr. Wright and Mr. Trefry will attend. This year's theme is "States Charting a Course for Change."

In addition, Mrs. Hopkins-Staten extended congratulations to Chief Operating Officer Charlene Russell-Tucker on being recognized as one of 100 Women of Color in 2015.

IX. Report of the Commissioner

Commissioner Dianna R. Wentzell referenced her written report (copy in official file). Commissioner Wentzell's report summarized several meetings that support the work and goals of the State Department of Education, including internal and external operations, numerous statewide back-to-school convocations, and meetings with legislators and the Governor's Office.

Dr. Wentzell asked Ajit Gopalakrishnan and Deputy Commissioner Ellen Cohn to provide an update on student performance. A copy of their PowerPoint presentation is enclosed in the official file of this meeting.

X. Financial Matters

Chief Finance Officer Kathy Demsey reported that the Department is approaching the next budget cycle, and will present budget adjustments and reduction options to the State Board of Education in October.

XI. Committee Reports

A. Academic Standards and Assessment.

Mr. Wright reported that the committee has reviewed English Language standards and socialemotional standards, and is scheduled to meet in September.

B. Accountability and Support

No report was given.

C. Finance, Audit and Budget

The Committee met on August 20, 2015, to discuss affirmative action matters and the work of the Office of Internal Audit.

D. Legislation and Policy

Mrs. Hopkins-Staten reported that the committee met this morning to discuss minority teacher recruitment initiatives in Waterbury, and received an update from Attorney Louis Todisco on the hearing officer selection process.

E. Connecticut Technical High School System

Mr. Trefry reported that the CTHSS received its SBAC results, and will focus efforts on improving mathematics performance. He noted that approximately 10,800 student were enrolled at the beginning of the 2015-16 school year, and reported on the manufacturing program at Bullard Havens, and a partnership between Henry Abbott and the local community college. Mr. Trefry said the system has had an increase in the number of students requiring special education services.

F. NASBE

Mr. Wright reported that the Governmental Affairs Committee is expected to take a formal position on the ESEA statute in the near future.
