# CONNECTICUT STATE BOARD OF EDUCATION Hartford

Minutes State Board of Education Meeting January 6, 2016 (approved February 3, 2016)

Pursuant to notice filed with the Secretary of the State, the State Board of Education (hereinafter "Board") met on Wednesday, January 6, 2016, in Room 1D of the Legislative Office Building, 300 Capitol Avenue, Hartford, Connecticut.

### I. Call to Order

Chairperson Allan Taylor called the meeting to order at 9:41 a.m.

### II. Public Participation

1. Dean Jones, parent of students who attend Achievement First Middle School, spoke in support of the quality of the experience his daughters have had as students at Achievement First, and noted that the teachers and staff are preparing his children with the academic and character skills needed for higher education and life. A copy of Mr. Jones' prepared statement is included in the official file of this meeting.

- 2. Josephine Pittman, parent of two scholars who attend Achievement First Middle School, spoke in support of the quality of education and staff at Achievement First, and noted that Achievement First is preparing her children for college and beyond. A copy of Ms. Pittman's prepared statement is included in the official file of this meeting.
- 3. Dr. Joseph V. Erardi, Superintendent of the Newtown Public Schools, updated the Board on the status of the Newtown Public School System since the December 2012 shootings at Sandy Hook Elementary School. He provided an overview of security measures that have been implemented, teaching and learning initiatives, and progress on the new Sandy Hook School. While much progress has occurred, the challenges resulting from the December 2012 incident will continue for decades, Dr. Erardi noted. He asked the Board to continue its support for Newtown's recovery efforts and invited Board members to visit the Newtown Public Schools.

Dr. Erardi presented the Board with a copy of "Best Practice Considerations for Addressing Student Mental Health Issues," "Proactive Risk Assessment Procedures," and "Security in the Newtown Public Schools 2008-2015, A Collaborative, All-in, Best Practice Approach." A copy of each document is included in the official file of this meeting.

- 4. Mr. Thomas Kuroski, President of the Newtown Federation of Teachers, spoke about Newtown's recovery efforts, noting they were far from complete, and asked the Board to respond to Newtown's unique challenges over the next decade.
- 5. Mr. Mark J. Pompano, Director of Security, Newtown Public Schools, stated that planning is the most important part of school security, and stated that the risk assessment procedures, contained in Newtown Public Schools Emergency Operations Plan, serve as a model for other districts.
- 6. Ms. Milly Arciniegas, Hartford Parent University, commended the Commissioner and Board on their timely response to the concerns raised by parents about the SAND Elementary School professional development training exercise on differentiated instruction. Ms. Arciniegas stated that districts must ensure that they hire staff members who do not have a history of discriminatory actions.
- 7. Ms. Gwen Samuel, public school parent and president of the Connecticut Parents Union, spoke about the importance of providing mental health support and services to students throughout the state, particularly in urban areas and for those children receiving special education services. She stated that there is an accountability issue in Connecticut (e.g., school governance councils, special education rates, district hiring practices) and more oversight is required by the state.
- 8. Ms. Ines Pegeas, Hartford resident, former teacher, and secretary of the African American Alliance, questioned what has been done to increase minority teacher recruitment and what will be done in the future. Ms. Pegeas stated that Hartford has

not been successful in recruiting teachers of color to its classroom, and noted that there is a need for instruction in cultural diversity.

### IV. Executive Session

## A. Discussion with Counsel Regarding Pending Litigation Involving the State Board of Education (CCJEF; Alicia B., et al)

On a motion by Mr. Vrabely, seconded by Mrs. Benham, the Board voted unanimously to move into executive session at 10:27 a.m. for the purpose of discussing with counsel pending litigation that involves the State Board of Education (CCJEF, Alicia B., et al.).

Present in executive session were Board members Mrs. Benham, Ms. Beyl, Mr. Clemons, Mr. Davenport, Mrs. Hopkins-Staten, Mr. Jones, Ms. Mojica, Mr. Noel-Sullivan, Ms. Sieve, Mr. Taylor, Mr. Vrabely, and Mr. Wright. Also present for all or part of executive session were Commissioner Wentzell, Assistant Attorney General Joseph Rubin, Assistant Attorney General Ralph Urban, and Director of Legal Affairs Peter M. Haberlandt.

On a motion by Vrabely, seconded by Mrs. Benham, the Board voted unanimously to move out of Executive Session and reconvene in public session at 11:48 a.m. Present were Mrs. Benham, Ms. Beyl, Mr. Clemons, Mr. Davenport, Mrs. Hopkins-Staten, Mr. Jones, Ms. Mojica, Mr. Noel-Sullivan, Ms. Sieve, Mr. Taylor, and Mr. Vrabely. Mr. Wright, Dr. Lopez, and Mr. Ojakian were absent.
